## **MEMORANDUM IN SUPPORT**

Vanguard is authorized to provide retail natural gas broker services in this state pursuant to Certificate No. 18-634G in Case No. 17-2485-GA-AGG and to provide electric aggregator services in this State pursuant to Certificate No. 14-900E in Case No. 14-1942-EL-AGG.

Pursuant to the Commission's entries issued on January 26, 2022, and June 29, 2022, in this case, Vanguard was to have submitted its Annual Reports for Fiscal Assessments for the calendar year 2021. Vanguard had been working on an internal reorganization of responsibilities for team members. Vanguard did not act quickly enough to file the Annual Reports by the deadline and apologizes for its inadvertent oversight in failing to file by the deadline. Vanguard notes that it has not been delinquent in any of its previous annual filings. Through this Motion, Vanguard requests leave to submit its 2021 Annual Reports.

Upon approval of this Motion and the unlocking of that report form in the PUCO Community, Vanguard will promptly proceed to submit its 2021 Annual Reports through the Commission's PUCO Community. In addition, Vanguard has already remitted payment for the \$1,000 civil forfeitures assessed consistent with the June 29, 2022 Entry, effective July 29, 2022 for both its retail natural gas broker certificate and its electric aggregator certificate.

WHEREFORE, Vanguard respectfully requests that the Commission grant its Motion and allow it to submit its Annual Reports for Fiscal Assessment for the calendar year 2021.
