Notice of Public Information Meeting For Proposed Major Utility Facility

AES Ohio invites Preble County residents and other interested members of the public to attend an informational open house for its proposed New Westville Area Improvements Transmission Line Project – two new 138,000-volt (138 kV) transmission lines. The improvement project involves building approximately 14 miles of new transmission lines, upgrading 5 miles of existing transmission lines, and a new distribution substation located between the West Manchester and the New Westville Area.

The public informational open house will be held from 5:00 to 7:30 PM, Wednesday, October 26, 2022, at National Trail High School, 6940 Oxford Gettysburg Road, New Paris, Ohio 45347. The informational open house provides the public an opportunity to meet and talk with project representatives and view detailed project maps. There is no formal presentation. Visitors may come and go at any time.

AES Ohio is committed to safe reliable service for new and existing customers, and upgrades are necessary to strengthen the electric transmission system. This area is currently served by a single 33 kV transmission line primarily constructed in the 1930s. A single outage on this line results in a complete outage to all customers served by the current New Westville Substation. The proposed lines will provide redundancy so that if an outage occurs on one line, the other will remain in-service. The new lines will improve service reliability to the customers in the area.

AES Ohio has extensively studied the general area between the substations to identify multiple route options for the transmission line to minimize any impacts to sensitive areas and land uses. Based on the study's preliminary results, AES Ohio has


identified the transmission line routes that are shown on the map below.

These routes under consideration largely follow road right-ofway, property lines, and AES Ohio's existing transmission line right-of-way. It is anticipated that the new line will be installed on steel monopoles, averaging 80 to 105 feet in height.

The Ohio Power Siting Board (OPSB) is responsible for reviewing project information, including public comments and input, and determining whether to issue a Certificate of Environmental Compatibility and Public Need approving the project. AES Ohio plans to file an application with the OPSB in early 2023 for OPSB review and approval of the transmission line siting. The application will include a preferred and alternate route for most sections of the project area.

If the application is approved by the OPSB, construction of the transmission line could begin in 2024 and be completed by June 2026. The docket number for the project is 22-0627-EL-BTX and shall be included with any correspondence.

Public comments will be accepted and considered by AES Ohio staff as part of the process of further evaluating the proposed routes.
