Dear Ms. Troupe:

AEP Ohio Transmission Company, Inc (the “Company”) files this pre-application notification letter for the above-referenced Project pursuant to Rule 4906-6-03(A) of the Ohio Administrative Code.

The Company is proposing the Crooksville – North Newark 138 kV Adjustment Project (the “Project”) that involves realigning approximately 0.43 miles of transmission line between AEP’s North Newark and Newark Center Station due to an issue constructing foundations for Structure 211 and 212. The remaining portion of the Crooksville – North Newark 138 kV line from Structure 210 to Newark Center Station has been filed in a separate application (Case No. 21-0852-EL-BLN).

The Company anticipates that construction of the Project will begin in February 2023. The anticipated in-service date for the Project is December 2024.

Pursuant to Ohio Adm. Code 4906-6-04, the Company requests expedited treatment of its application for this Project. Consistent with Ohio Adm. Code 4906-6-04(A), a copy of the Company’s application will be submitted to the executive director or the executive director’s designee at or before the application’s filing. A copy will also be provided to the Board Staff via electronic message. The Company will also submit a check in the amount of \$2,000 to the Treasurer, State of Ohio, for Fund 5610 for the expedited fees.
