On 09/21/2022, a vehicle operated by L&R JONES TRANSPORTATION LLC, and driven by, JONES, ROOSEVELT H was inspected within the state of Ohio. As a result of discovery of the following violation(s) of the Commission's rules, Staff of the Commission timely notified L&R JONES TRANSPORTATION LLC pursuant to rule 4901:2-7-07, Ohio Administrative Code (OAC), that it intended to assess a civil forfeiture against L&R JONES TRANSPORTATION LLC in the following amount:
