**MOTION TO INTERVENE AS A PARTY OF THE BOARD OF TRUSTEES OF
MONROE TOWNSHIP, MADISON COUNTY, OHIO**


Pursuant to Ohio Revised Code Section 4906.08 and Ohio Administrative Code (“OAC”) Rule 4906-2-12, the Board of Trustees of Monroe Township, Madison County, Ohio submits its notice of intervention in the above referenced proceeding. Monroe Township was served a copy of the Oak Run Solar Project, LLC (“Oak Run”) application to develop, build, and operate the Oak Run facility, a solar-powered electric generation facility to be located in Madison County, Ohio.

In accordance with OAC Rule 4906-2-12 the Board of Trustees of Monroe Township state as follows:

- The Board of Trustees of Monroe Township is the duly elected body authorized to act for Monroe Township and has taken the required action to intervene, as certified by the attached resolution (Attachment A).
- The proposed facility is to be located partially within Monroe Township, with such area under the jurisdiction of the Board of Trustees of Monroe Township.
- The Board of Trustees of Monroe Township intends to intervene, as the elected representatives of the citizens of Monroe Township, because it has extensive interest in the proposed project and proceedings in regards to ensuring the township roads, waterways and environment are dealt with in a way that does no harm to the township.
- The interest of the Board of Trustees of Monroe Township are not and cannot be represented by another party; the Board of Trustees of Monroe Township will contribute to a just and expeditious resolution; and the Board of Trustees of Monroe Township will not unduly delay the proceedings or unjustly prejudice any party.
