**MOTION FOR ENTRY NUNC PRO TUNC
REQUEST FOR EXPEDITED RULING
AND MEMORANDUM IN SUPPORT**

On December 15, 2022, the Ohio Power Siting Board (“Board”) issued its Opinion and Order (“Order”) in this matter approving and adopting the Joint Stipulation and Recommendation (“Stipulation”) filed by Grover Hill Wind, LLC (“Applicant”) and the Board’s Staff (“Staff”) (jointly referred to herein as “Signatory Parties”) on October 7, 2022.

Pursuant to Ohio Administrative Code (“O.A.C.”) 4906-2-27, the Applicant respectfully requests the Board, on an expedited basis, issue an entry nunc pro tunc to correct the name of the Applicant in the Order. Specifically, consistent with the Application filed on May 3, 2021, as supplemented, and the Stipulation, the Applicant requests that the Board state that Grover Hill Wind, LLC, is the name of the entity that received the certificate pursuant to the Order.

The Applicant has consulted with Staff and Staff does not oppose this motion or the request for expedited treatment.

Therefore, the Applicant submits that, for the reasons more fully set forth in the following memorandum in support, good cause exists to grant this motion on an expedited basis, in accordance with O.A.C. Rule 4906-2-27(C).

**MEMORANDUM IN SUPPORT OF
MOTION FOR ENTRY NUNC PRO TUNC AND
REQUEST FOR EXPEDITED RULING**

On May 3, 2021, as supplemented, the Applicant, Grover Hill Wind, LLC, filed an Application with the Board for a certificate to construct a wind-powered electric generation facility in Paulding County, Ohio (“Application”). The Staff filed its Staff Report of Investigation on January 24, 2022, as supplemented on September 9, 2022 (“Staff Report”). On October 7, 2022, the Applicant and Staff filed a Stipulation. The evidentiary hearing was held on October 19, 2022.

On December 15, 2022, the Board issued its Order in this matter approving and adopting the Stipulation filed by the Applicant and Staff on October 7, 2022. From a review of the Order, it appears the Board inadvertently called the Applicant Grover Hill Wind *Farm*, LLC, rather than the correct company name, Grover Hill Wind, LLC, in the title and the body of the Order. The Stipulation, as well as the Application and all filings by the Applicant in the docket properly state that the Applicant is Grover Hill Wind, LLC (without the word *Farm*).

While the Stipulation adopted and approved by the Board correctly states that the Applicant’s name is Grover Hill Wind, LLC, it is important that the Board correct the Order to ensure there is no discrepancy that might hinder or be called to question in the financing of the project.

Therefore, the Applicant respectfully requests the Board issue an entry nunc pro tunc on an expedited basis correcting the Order and stating that the name of the certificate holder in this case is Grover Hill Wind, LLC.
