- {¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination upon Julio C. Hernandez Gonzalez (Respondent) alleging a violation of the Commission's transportation regulations.
- {¶ 2} On March 24, 2022, Respondent's counsel filed a request for an administrative hearing as permitted by Ohio Adm.Code 4901:2-7-13.
- {¶ 3} By Entry dated May 6, 2022, the attorney examiner scheduled a prehearing settlement conference in this matter for May 26, 2022. During the conference, the parties were unable to settle the matter.
- {¶ 4} By Entry dated May 31, 2022, the attorney examiner scheduled a hearing for August 9, 2022, to occur at the offices of the Commission.
- {¶ 5} On August 9, 2022, the hearing occurred as scheduled. During the hearing, a Staff witness was not present, and Respondent's counsel informed the Commission that it required a Spanish language interpreter. The hearing was therefore called and continued.
- {¶ 6} By Entry dated November 10, 2022, the attorney examiner rescheduled the hearing to occur on January 12, 2023.
- {¶ 7} On December 08, 2022, Respondent filed a motion for continuance of the hearing scheduled to commence on January 12, 2023 based on a scheduling conflict. No party filed a timely memorandum contra this motion.
- $\{\P 8\}$ On December 29, 2022, Staff filed a motion to dismiss the case owing to the retirement of the inspector who issued the citation in this case.
