RIDER GTCJA

GAS TAX CUTS AND JOBS ACT RIDER

APPLICABILITY

Applicable to all customers receiving service under the Company's sales and transportation rate schedules. This Rider will be updated to reflect any future changes in federal tax law impacting the Company.

RATE

The monthly billing amount calculated for each rate schedule shall be adjusted by the amount or the billed usage multiplied by the applicable charge or credit as indicated below.

Rate RS and RSLI, Residential Service	\$ (0.50) / Month
Rate RFT and RFTLI, Residential Firm Transportation Service	\$ (0.50) / Month
Rate GS-S and FT-S, General Service and Firm Transportation Small	\$ (1.52) / Month
Rate GS-L and FT-L, General Service and Firm Transportation Large	\$ (6.16) / Month
Rate IT, Interruptible Transportation Service	\$ (0.0014) / Ccf
Rate GGIT, Gas Generation Interruptible Transportation Rate	\$ (0.0014) / Ccf

SERVICE REGULATIONS
