Dear Ms. Troupe:

Pursuant to the November 2, 2022, Entry in Case No. 21-1205-EL-AEC, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, "Companies"), Toshi CMC, LLC and Commission Staff have met to discuss implementation of the most cost-effective of the proposed manual billing options. This is to notify the Commission that the parties, along with Staff, have determined the most cost-effective option is a manual billing process to directly bill Toshi for transmission service consistent with the Rider NMB Pilot program while Toshi remains on the standard service offer ("SSO").

The NITS charge under the manual billing process will be based upon the daily NITS rate applied to the customers' NSPL. The manual billing process for all other NSPL-based charges from the Companies' PJM bill will be based upon an allocation of the amounts on the Companies' PJM invoice, using the ratio of the customer's NSPL compared to the total NSPL for all of the Companies' customers. For kWh-based charges from the Companies' PJM bill, the manual bill will be calculated by allocating the total kWh-based charges from the Companies' PJM bill using the ratio of the customer's energy usage compared to the total kWhs of all the Companies' customers. The monthly bill from the Companies will include the manually calculated transmission services charge along with a miscellaneous charge for the incremental costs associated with implementing the manual billing process. The Companies will implement this manual billing for Toshi and will make this process available to Rider NMB Pilot participants going forward. Upon request, the Companies will also facilitate the return to the Rider NMB Pilot of former Pilot participants who recently returned to the SSO and make the manual billing process available to them going forward while they remain on SSO.
