The Legacy Energy Group, LLC, ("Legacy Energy") is authorized to provide competitive retail natural gas retail natural gas broker services in Ohio pursuant to Certificate No. 19-731G in Case No. 19-1862-GA-AGG and competitive retail electric power broker services in Ohio pursuant to Certificate No. 11-408E in Case No. 11-5492-EL-AGG.


Pursuant to the PUCO's directive in its January 26, 2022 and July 29, 2022 Entries in this docket, the PUCO ordered Legacy Energy to submit its Annual Reports for Fiscal Assessment for calendar year 2021. Legacy Energy did not submit their Annual Reports for calendar year 2021 by the deadline. At the time that the annual reports were due, Legacy Energy was in the process of transferring responsibilities related to the filing of the annual reports, and due to that re-organization did not timely file the annual reports for calendar year 2021. After discovering this, Legacy Energy reached out to PUCO staff to determine how to proceed and correct the error. Legacy Energy was informed that they needed to file a Motion for Leave to file their 2021 Annual Reports, and that they could request a waiver of the \$1,000.00 forfeiture that was assessed related to the natural gas annual report and the \$1,000.00 forfeiture that was assessed related to the electric annual report. Legacy Energy apologizes for this failure to timely file their 2021 annual reports and does not intend to make a habit of similar occurrences. Legacy Energy through this Motion requests leave to submit their 2021 annual reports.

Upon approval of this Motion, Legacy Energy will promptly proceed to submit their 2021 Annual Reports through the PUCO Community website. Legacy Energy will also process and remit payment for their annual assessment imposed under R.C. 4905.10. Legacy Energy respectfully requests that any forfeitures or late filing penalties, including the two \$1,000.00

forfeitures referenced above, be rescinded, but will timely process and remit payment for such forfeitures if they are not.

WHEREFORE, for the above-stated reasons, Legacy Energy respectfully requests that the PUCO grant its Motion and allow it to submit its Annual Reports for Fiscal Assessment for calendar year 2021.


