**MOTION FOR LEAVE TO FILE AMENDED ANNUAL REPORTS FOR CALENDAR  
YEAR 2021 OF INFINITY POWER PARTNERS, LLC**

---

Infinity Power Partners, LLC (“Infinity”) is a certified Ohio Competitive Retail Natural Gas Broker under certification Case No. 13-1740-GA-AGG and a certified Competitive Retail Electric Service Provider under certification Case No. 15-1476-EL-AGG. Pursuant to the Commission’s entries in this docket, Infinity filed its Annual Reports for calendar year 2021, both gas and electric, on April 21, 2022. After receiving assessments based on the revenues reported in each Annual Report, Infinity determined that it had mistakenly reported usage (kWh and therms) instead of revenues, thereby substantially inflating Infinity’s actual revenues. This mistake was the result of a clerical error. Infinity has communicated with Staff for several months to remedy the error, and now understands that this Motion is necessary to correct the Annual Reports.

To ensure that accurate information is provided to the Commission, Infinity respectfully requests that the Commission grant this Motion and permit Infinity to amend its Annual Report for calendar year 2021 to correct the revenues reported. Infinity then would make arrangements with the Commission’s Fiscal Office to submit the amended Annual Reports electronically. In addition, Infinity also respectfully requests that the Commission adjust its invoices to reflect the corrected revenues so that Infinity can then promptly remit the adjusted assessment.
