14	8.	Q.	Why is Staff recommending condition 25?
15		A.	This condition outlines the requirements the Applicant must meet to mitigate
16			disruption of agricultural field drain tile systems.

18	9.	Q.	Does this conclude your testimony?
19		A.	Yes, it does. However, I reserve the right to submit supplemental testimony,
20			as new information subsequently becomes available or in response to
21			positions taken by other parties.
