6 A. I am employed by the Public Utilities Commission of Ohio (PUCO) as a
7 Public Utilities Specialist 2 within the Power Siting Department.

10 A. I received a Bachelor of Science Degree in Environment and Natural
11 Resources from The Ohio State University in Columbus, Ohio.

13 I have been employed by the PUCO since August 2021. My responsibilities
14 during this time have primarily involved review of Ohio Power Siting Board
15 (Board) cases. My focus has been reviewing ecological and surface water
16 impact.

18 5. Q. Have you testified in prior proceedings before the Board?

21 6. Q. What is the purpose of your testimony in this proceeding?

1 A. I am sponsoring portions of the Staff Report of Investigation (Staff Report)
2 that was filed in the docket of this case on May 10, 2022. Specifically, I am
3 sponsoring the Staff Report subsections titled Surface Waters, Threatened
4 and Endangered Species, and Vegetation.

6 7. Q. Are you sponsoring any conditions? If so, which ones?

7 A. Yes. I am sponsoring conditions 30, 31, 32, 33, 34, 35, 36, and 37 of the
8 Staff Report.

10 8. Q. Why is Staff recommending these conditions?

11 A. These conditions are needed to ensure the minimization of potential adverse
12 impacts to surface water resources, wildlife, and vegetation.
