The Project will include expansion of the existing approximately 1.76-acre substation fence by approximately 0.22 acre (14%) to the northeast. The steel lattice tower adjacent to the substation fence expansion will be replaced with two steel monopoles with new conductor installed from the take-off structures for each circuit within the substation to the two proposed new steel monopoles installed outside of the substation.
