I am writing this letter in regard to the proposed power lines on our land. As I talked to a gentleman a couple weeks ago about our concern I thought maybe I should put something on paper just in case that got lost.

One property that will be affected by these power lines has been in the McWhinney family since 1834! We are not large aggressive farmers but we love the land and care for how it is treated. We make our living off farming and cannot afford to lose land to put up electric poles. It is a beautiful drive down Westville Road any season of the year and the compliments we get for our stewardship are as meaningful to our family as the money we make farming.

The other land is on Cox Road. I started renting that land around 1970. In 2015 after saving and doing without a lot of things for years we purchased the land. We have put in Government approved waterways, tiled and no-tilled (for last 30 years), and as you might guess, I treat the land as I would like to be treated. This particular farm was home to Indian settlements and in past years Earlham College used to do supervised digs to study the contents of the soil.

In summary of this letter, I have witnessed windmills, solar panels and even power lines, (from Dayton to Eaton) being constructed. What a total mess and they destroy the landscape. We have many stories as we have friends along that construction to Eaton that are not happy. I hope our feelings have been made clear and no monetary offer would even be considered for this project going through our land! We are longtime Farm Bureau members also. If farmers continue letting farmland to be disrupted, our country and the world are destined for hardship!
