The following AT&T Ohio bill page message was printed on the bills of impacted **residential** customers from 11/6/2022 through 12/6/2022.

#### **Rate Notice**

The monthly rate for residential Flat Rate Service will increase by \$2 on 1/15/2023. Customers with certain packages and bundles will not be affected by the increase. For more information, please visit us at att.com or call 800.288.2020.

**Note:** A residential customer's local exchange service consists of <u>three tariffed components</u>: a network access line, a central office termination and usage. However, these <u>three tariffed components</u> are displayed as <u>two charges</u> on the customer's bill, a Line Charge and a Usage Charge. For example, for flat rate local service, using rates in effect prior to 1/15/2023; the rate is calculated and shown on the bill as follows:

Network Access Line	\$22.40 —	Displayed as \$24.70 "Line Charge" on the bill.
Central Office Termination	\$2.30	
Flat Rate Usage	\$7.55	Displayed as "Unlimited Residence Service" charge on the bill.
Total	\$32.25	

Customer bills display a Line Charge of \$24.70, which is a combination of the network access line rate (\$22.40) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 1/15/2023 rate increase, the tariffed rate for a flat rate residential network access line will increase by \$2.00, going from \$22.40 to \$24.40. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$24.70 to \$26.70. So, for flat rate local service, using rates in effect subsequent to 1/15/2023, the rate will be calculated and shown on the bill as follows:

Network Access Line	\$24.40 —	Displayed as \$26.70 "Line Charge" on the bill.
Central Office Termination	\$2.30	
Flat Rate Usage	\$7.55	Displayed as "Unlimited Residence Service" charge on the bill.
Total	\$34.25	

Customers affected by the rate increase will see their bill for flat rate local service increase from \$32.25 (\$24.70 + \$7.55) to \$34.25 (\$26.70 + \$7.55).
