**MOTION FOR PERMISSION FOR MATTHEW EISENSEN TO APPEAR

Pursuant to Rule XII of the Supreme Court Rules for the Government of the Bar of Ohio (“Gov. Bar R.”) and Ohio Administrative Code Rule 4906-2-26(B), Movant respectfully requests that the Ohio Power Siting Board grant permission to Matthew Eisenson (PHV-26622-2023) to appear *pro hac vice* on behalf Dr. John Boeckl in the above-captioned proceeding.




