Staging Area Update

Dear Ms. Troupe:

Fox Squirrel Solar, LLC ("Applicant") is certified to construct a solar-powered electric generation facility in Madison County, Ohio, in accordance with the orders issued by the Ohio Power Siting Board ("OPSB") in the above-referenced cases.

The purpose of this letter is to update OPSB regarding a temporary staging area for the project construction. The Applicant has been exploring ways to limit the impact of construction traffic on the county roads and on the neighboring community. To support this goal, the Applicant has located a temporary staging area on an existing vacant brownfield site that is located south of Interstate 71 on the east side of State Route ("SR") 56. Utilization of this staging area will eliminate a large loop for drivers and ultimately eliminate approximately 1,150 trucks from using county roads for the delivery of solar modules. No offloading or storage will occur at this staging area; rather, the area will be used to meet the truck, confirm the content of the load, and then direct the driver to the entrance on SR 56.

This update is being provided in compliance with the OPSB's July 15, 2021 Order in Case No. 20-931-EL-BGN. This information was provided to OPSB Staff on March 8, 2023.
