# 1 Q.1 Please state your name, title, and business address.

A.1 My name is Zack Melda. I am a Senior Director for NextEra Energy Resources, LLC. My
business address is 700 Universe Boulevard, North Palm Beach, FL 33408.

4 Q.2 What are your duties as Senior Director of Development at NextEra?

A.2 My duties include managing development activities for our portfolio of renewable energy
projects throughout Ohio, Indiana, Illinois, and Michigan. The portfolio consists of
approximately 2 GW of Solar, 400 MW of Wind, and 357 MW of Storage projects in
various stages of development and construction. Development activities include, but are
not limited to: site suitability analysis, land acquisition, interconnection applications,
community engagement, federal state and local permitting, budgeting oversight, and
oversight of engineering and construction.

# 12 Q.3 What is your education and professional background?

- A.3 13 I have worked at NextEra Energy Resources since May 2016 and currently serve in the role of Senior Director of Development. Prior to NextEra Energy Resources I worked for 5 14 15 years at Georgia Pacific, LLC in the pulp and paper industry and as an environmental engineer. Additionally, I served in the U.S. Army for 4 years active duty, and for 12 years 16 in the National Guard. I hold a Bachelors degree in civil engineering from Southern 17 Polytechnic State University, and a Masters in Business Administration from the Georgia 18 19 Institute of Technology. A copy of my resume is attached to my testimony as Attachment 20 A.

- A.4 I am offering testimony on behalf of the Applicant, Circleville Solar, LLC ("Circleville
  Solar").

# .6 What is the general purpose of the Project?

A.6 The Project's general purpose is to generate renewable energy to the PJM Interconnection,
 LLC ("PJM") transmission grid that serves the eastern United States. The Project will
 provide a clean, efficient, zero-emission alternative to fossil fuel-fired power stations. The
 Project utilizes an array of photovoltaic (PV) panels with a generating capacity of
 approximately 70 MW. The intent of the Project is to help in diversifying the portfolio of
 local, state, and national energy generators to provide more energy with minimal
 environmental impacts.

# Q.7 Does the energy generated by the Project have a specific purpose for customers located in Ohio?

A.7 Yes. The Project will provide direct benefits to over 600,000 electric customers through an
offtake agreement with the Northeast Ohio Public Energy Council ("NOPEC").

# Q.8 Please describe the proposed Project, the Project Area, and the power generation potential of the Project.

**A.8** The Project is a 70 MW solar-powered electric generating facility for which Circleville 22 Solar has applied to the OPSB for a certificate to construct in Jackson Township, Pickaway 23 County, Ohio. As discussed further below, the Project Area has been reduced to The 24 Project's components, within the fence line, will be located on approximately 756 acres. 25 As stated in the Application, this acreage is representative of an overbuild design, and so 26 the final acreage actually utilized for the Project facility components will be less than 756 27 acres. The Project will be located on rural, relatively flat, previously disturbed agricultural 28 29 land.

1 The Project will consist of arrays of PV panels, which will be ground-mounted on a single-2 axis tracking rack system. The racking includes steel posts driven six to eight feet into the 3 ground. The solar panel arrays will be fenced with gated entrances. The Project facility 4 also includes access roads, electric collection lines, a collection substation, and a laydown 5 area for construction staging. The Project will also have an approximately 3.5-mile gen-tie 6 facility to connect the Project to an existing substation in Circleville, which is the subject 7 of a separate application filed with the OPSB.<sup>1</sup>

# 8 Q.9 What components of the Application are you sponsoring?

A.9 I am sponsoring the Application narrative, all certificates of service, all required proofs of
publications, and all other letters and documents required by OPSB rules. I am also
sponsoring the following Exhibits to the Application: Exhibit A (Application Figures),
Exhibit B (Project Schedule), Exhibit C (Manufacturing Specifications), Exhibit G
(Interconnection Feasibility), Exhibit I (Complaint Resolution Plan), Exhibit M (Glint &
Glare Analysis), Exhibit S (Drain Tile Maintenance Plan). The Application and all Exhibits
thereto are collectively "Applicant Exhibit 2."

# Q.10 In addition to the Application Exhibits listed above, are you sponsoring other exhibits?

A.10 Yes, I am also sponsoring all of Circleville Solar's Responses and Supplemental Responses to the Staff Data Requests (Applicant Exhibit 3), as well as the Additional Geotechnical and Subsurface Infrastructure Information filed on October 28, 2022 (Applicant Exhibit 4).
I am sponsoring the Notice of Project Modification filed on March 10, 2023 (Applicant Exhibit 5). Finally, I am also sponsoring the Facilities Study Report, Executed Interconnection Service Agreement, and Executed Interconnection Construction Service Agreement, filed March 13, 2023 (Applicant Exhibit 6).

1	Q.11	Are Circleville Solar's Application Exhibits and responses to Staff Data Requests true
2		and accurate to the best of your knowledge?
3	A.11	Yes, the Application and Exhibits and all of Circleville Solar's Responses and
4		Supplemental Responses to the Staff Data Requests are true and accurate and were
5		prepared under my direction.
6	Q.12	Were copies of the accepted Application served on local public officials and libraries
7		in accordance with OAC Rule 4906-3-07(A)?
8	A.12	Yes, such service was made, and I am sponsoring Applicant Exhibit 7, which is proof of
9		service of the Application.
10	Q.13	Did Circleville Solar file and serve a copy of the letter sent to property owners and
11		tenants with the plan or contiguous to the plan site pursuant to OAC Rule 4906-3-
12		03(B)?
13	A.13	Yes. A letter was sent on October 28, 2021, to property owners and tenants within the plan
14		site or contiguous to the plan site announcing that the Public Informational Meeting would
15		be held on November 18, 2021. (See Applicant Exhibit 8.)
16	Q.14	Did Circleville Solar cause notice of the Public Informational Meetings, the
17		Application, and the hearing dates to be published in the local newspaper?
18	A.14	Such notices were published in the Circleville Herald at the appropriate time. Proof of
19		publication in this newspaper was filed on the docket on November 4, 2021. (See Applicant
20		Exhibit 9.)
21	Q.15	Did Circleville Solar publish notification of the originally scheduled hearing?
22	A.15	Yes. Proofs of Publication were filed on April 21, 2022 (first publication of the description
23		of the application and hearing dates) and June 23, 2022 (second publication of the
24		description of the application and hearing dates) in accordance with Ohio Revised Code
25		("R.C.") 4906.06(C) and O.A.C. 4906-3-10(B) for the first and second publications of the
26		description of the application and the hearing dates, published on April 19, 2022 and June
27		18, 2022 in the Circleville Herald. (Applicant Exhibit 10).

# 1 Q.16 Did the Project receive any comments at the public information meeting?

2 A.16 Yes. These comments are summarized in the Application.

# 3 Q.17 Has the Project received a PJM interconnection study?

4 A.17 Yes. These studies were filed with the Application (Exhibit G to the Application.)

# Q.19 Did the Project complete a complaint resolution plan?

A.19 Yes. The Project submitted a complaint resolution plan as part of its Application (Exhibit
 I). Pursuant to this plan, Circleville Solar will take all reasonable actions necessary to
 rectify legitimate disturbances that are a direct result of the Project. Where reasonable
 actions fail to minimize the disturbance, Circleville Solar will continue to work with the
 impacted community member to rectify legitimate disturbances.

# Q.20 Did the Project complete a glint and glare analysis?

A.20 Yes. The Project submitted a glint and glare analysis as part of its Application (Exhibit M).
 This analysis showed that there is no predicted glare occurrences for nearby residences or
 roadways as a result of the proposed single-axis tracking arrays. The results are based on
 the application of Federal Aviation Administration (FAA) glint and glare standards.

# Q.21 Did the Project Complete a Drain Tile Maintenance Plan?

A.21 Yes. The Project submitted a Drain Tile Maintenance Plan as part of its Application (Exhibit S). The purpose of this plan is to support the identification of drainage systems and methods for avoidance, mitigation, and repair of potential impacts caused by construction of the facility. As part of the preparation of this plan, the Applicant engaged local drain tile expert Mr. Mark Ruff. Mr. Ruff's testimony further describes how he supported the development of the Drain Tile Management Plan.

# 13 Q.22 Please describe the Notice of Project Modification filed on March 10, 2023.

- A.22 As originally proposed, the Project was located in both Jackson and Wayne Townships
   within Pickaway County, with most of the Project in Jackson Township. Through this
   modification filing, Circleville Solar is providing notice to the Board of a commitment to
   withdrawal the Project from Wayne Township. The modification filing shows the revised
   Project Area boundaries demonstrating the removal of the Project Area from Wayne
   Township. The filing makes no changes to the existing Project Area boundary in Jackson
   Township.
- 21 Q.23 Have you reviewed the Staff Report of Investigation?
- 22 **A.23** Yes.

# Q.24 Have you reviewed the Certificate Conditions recommended by the Board Staff on pages 46-54 of the Staff Report of Investigation?

25 A.24 Yes

# Q.25 Does Circleville Solar recommend any changes to the conditions as proposed in the Staff Report?

A.25 Yes. Circleville Solar recommends that the following proposed conditions in the Staff
Report be removed: Condition No. 6; Condition No. 8, Condition No. 10, Condition No.
37; and Condition No. 38. The issues related to these conditions have been subsequently
resolved in the discussions with OPSB Staff, followed by the Additional Geotechnical and
Subsurface Infrastructure Information filed on October 28, 2022.

8 More specifically, Condition Nos. 6, 37, and 38 state:

9 (6) Additional geotechnical borings shall be conducted and those results 10 presented with the final geotechnical report. This shall include, but not be 11 limited to borings at the collector substation location, the collection line 12 corridor between the solar array field and the collector substation, and 13 within the group of solar arrays proposed in the southeast corner of the 14 project area. The additional geotechnical evaluation shall include pile load 15 testing throughout the project area where pile foundations are proposed.

- (37) The Applicant shall not construct within the 46-acre panel array section
  in the southeastern portion of the project area located on Parcel ID No. P330-001-00-374-00 and identified within its February 10, 2022 data request
  response where geotechnical borings remain to be conducted, performed,
  and analyzed.
- (38) The Applicant shall not construct within the collector substation area
  located on Parcel ID No. E15-0-001-00-196-00 and identified within its
  February 10, 2022 data request response where geotechnical borings remain
  to be performed and analyzed.
- The Additional Geotechnical and Subsurface Infrastructure Information filing included an updated Geotechnical Evaluation Report that resolves the issues raised in the proposed conditions above. As a result, these conditions can and should be eliminated.
- 28 Staff Report Condition No. 10 states:
- (10) At least 60 days prior to the preconstruction conference, the Applicant
  shall provide to Staff and file on the public docket, a final subsurface

investigation report. This report shall identify the precise locations of all 1 2 buried lines related to the oil and gas operations in and around the project 3 area. This will include a revised facility layout to identify all features and incorporate the setbacks of conditions 8 and 9 above, in addition to inclusion 4 of a 10 feet minimum setback from any buried lines identified by the 5 subsurface investigation report. This setback shall not supersede any 6 binding setbacks established under any existing oil and gas operations lease 7 agreements. 8

9 As described in the Additional Geotechnical and Subsurface Infrastructure Information 10 filed on October 28, 2022, the Applicant conducted additional subsurface investigations to 11 identify underground infrastructure. Through dialogue with the well operator, and 12 coordination with the Ohio Department of Natural Resources, it was determined that the 13 water line serving the well will be relocated. The testimony of Witness Locker further 14 discusses this investigation effort and coordination with the well owner.

15 Condition No. 8 states:

(8) The Applicant shall identify the precise locations of the plugged oil and
gas wells (API #s 34129202460000 and 34129201110000) and observe a
minimum setback of 50 feet between all project infrastructure and the wells.
This setback shall not supersede any binding setbacks established under any
existing oil and gas operations lease agreements.

As further addressed in the testimony of Witness Locker, the Additional Geotechnical and Subsurface Infrastructure Information filing confirmed the location of the wells and confirmed that the Project will adhere to a setback of at least 50 feet. With this confirmation, the proposed condition above is no longer necessary.

# Q.26 Does Circleville Solar recommend any other changes to the conditions proposed in the Staff Report?

A.26 Yes. Circleville Solar recommends minor clarification edits to Condition Nos. 12 and 21.
 Circleville Solar recommends that Condition No. 12 be modified to remove the reference
 to "physical barriers" to oil and gas well operations. The owner of the wells within the
 Project footprint, Houghton Investments, has communicated that fencing around the wells

will not be needed. As a result, Circleville Solar recommends the revised version of the
condition below:

At least 30 days prior to the preconstruction conference, the Applicant shall submit 3 a refined solar facility layout that shows the oil and gas well operation subsurface 4 infrastructure or right-of-way, the Applicant's setback of solar panels and inverters 5 and physical barriers to that oil and gas well operation subsurface infrastructure or 6 7 right-of-way, the access roads necessary to avoid interference with the oil and gas well operation), the location of the Applicant's underground electric collection 8 9 system within any pipeline(s) easement(s) or right-of-way, and the method for installing the underground electric collection system within the pipeline(s) 10 easement(s) or right-of-way. 11

Circleville Solar also recommends that Condition No. 21 is clarified to align with the Staff Recommendation that vegetative screening to mitigate aesthetic impacts is applicable to the limited portion of the Project that falls within the Immediate Foreground zone (0 to 0.1 miles) to the roadway. *See*, Staff Report at p. 14. This recommended edit better clarifies the applicability of certain mitigation requirements in light of the extensive setbacks applicable to most of the Project footprint. The revised condition is included below:

Prior to commencement of any construction, the Applicant shall prepare a 18 19 landscape and lighting plan in consultation with a landscape architect licensed by the Ohio Landscape Architects Board that addresses the aesthetic and lighting 20 21 impacts of the facility with an emphasis on any locations where an adjacent nonparticipating parcel contains a residence with a direct line of sight to the project 22 23 area. The plan shall also address potential aesthetic impacts to nearby communities, the travelling public, and recreationalists by incorporating appropriate landscaping 24 25 measures such as shrub plantings or enhanced pollinator plantings. Specifically, aesthetic impact mitigation of vegetative screening shall apply to the northwest 26 27 portion of the project that is adjacent to OH-56 and falls within the Immediate Foreground zone (0 to 0.1 miles) to the roadway. The plan shall include measures 28 such as fencing, vegetative screening, or good neighbor agreements. Unless 29 alternative mitigation is agreed upon with the owner of any such adjacent, non-30 31 participating parcel containing a residence with a direct line of sight to the fence of

the facility, the plan shall provide for the planting of vegetative screening designed 1 2 by the landscape architect to enhance the view from the residence and be in 3 harmony with the existing vegetation and viewshed in the area. The Applicant shall maintain vegetative screening for the life of the facility and the Applicant shall 4 replace any failed plantings so that, after five years, at least 90 percent of the 5 vegetation has survived. Prior to commencement of construction, the Applicant 6 shall submit to Staff for approval a solar panel perimeter fence type that is both 7 small-wildlife permeable and aesthetically fitting for a rural location. This 8 condition shall not apply to substation fencing. The Applicant shall maintain all 9 fencing along the perimeter of the project in good repair for the term of the project 10 and shall promptly repair any damage as needed. Lights shall be motion-activated 11 12 and designed to narrowly focus light inward toward the facility, such as being downward facing and/or fitted with side shields. The Applicant shall provide the 13 14 plan to Staff and file it on the public docket for review and confirmation that it complies with this condition. 15

# Q.27 With the exception of the Staff Report conditions identified in the previous questions, does the Applicant accept all remaining Certificate conditions recommended by the Board's Staff in the Staff Report and commit to complying with them?

19 A.27 Yes.

# Q.28 Are you aware that the OPSB must make certain determinations under Ohio Revised Code ("R.C.") 4906.10 before issuing the certificate for which Circleville Solar has applied?

A.28 Yes. I have been advised there are eight criteria considered by the OPSB in making its
decision whether or not to issue a certificate.

# Q.29 Does the Application meet Circleville Solar's obligation to make the required showings under each of the eight criteria under R.C. 4906.10?

A.29 Yes, the Application and other exhibits presented in this proceeding on behalf of the Project
 enable the OPSB to determine that Circleville Solar meets each of the eight criteria under
 R.C. 4906.10.

Q.30 Does R.C. 4906.10(A), which requires the Board to determine the basis of need for the
 proposed facility, apply to the Board's review of this Application?

A.30 No. R.C. 4906.10(A)(1) applies only to an electric transmission line or a gas pipeline and
is not applicable to this generating facility.

5 6 Q.31 Does the Application enable the Board to determine the nature of the probable environmental impact of the facility? [R.C. 4906.10(A)(2)]

A.31 Yes. The Application addresses all of the subject matter areas necessary for the Board to determine the nature of the probable environmental impact of the facility. The Application includes detailed surveys, assessments, and reports related to probable socioeconomic impacts, ecological impacts, and public services, facilities, and safety. The Application narrative and exhibits and figures, along with subsequent data request responses and filings, provides all of the information necessary to determine the probable impacts.
Further, each of these topics are supported by witnesses in the case.

In part, the Staff Report of Investigation recommended denial of the application under R.C. 4906.10(A)(2) due to insufficient geotechnical and subsurface infrastructure. Subsequent to the Staff Report, Circleville Solar provided additional investigative information to the OPSB Staff, followed by the Additional Geotechnical and Subsurface Infrastructure Information filed on October 28, 2022. As a result of this additional information, Staff confirmed in written correspondence to Circleville Solar that Staff no longer recommends denial of the Application under R.C. 4906.10(A)(2).

Q.32 Based on the Applicant's commitments in the Application, along with the conditions
 in the Staff Report, does the facility represent the minimum adverse environmental
 impact, considering the state of available technology and the nature and economics of
 the various alternatives, and other pertinent considerations? [R.C. 4906.10(A)(3)]

A.32 Yes. The Application addresses all of the subject matter areas necessary for the Board to
determine the nature of any probable environmental impact of the facility. Moreover, the
Applicant's commitment to comply with the conditions recommended by the OPSB Staff
in the Staff Report further supports a determination that the facility represents the minimum
adverse impact, considering the state of available technology and the nature and economics
of the various alternatives, and other pertinent considerations.

With respect to construction, such activities are expected to have typical and relatively
 limited impacts as they are temporary, intermittent, and subject to time-of-day restrictions.
 Increased traffic during construction will be managed with no expected road closures and
 will end when the Project is operational.

With respect to operations, on behalf of Circleville Solar, my team and I engaged, directed, 5 and supervised consultants to study the potential environmental, ecological, cultural, and 6 7 visual impacts of the Project. Individual witnesses provide further direct testimony on these studies and reports. Additionally, Circleville Solar's studies determined that there will be 8 9 no permanent adverse impacts to wetlands and surface waters. To the contrary, as set forth in the pre-filed testimony of Witness Gebhardt and Witness Locker the Project will 10 improve nearby watersheds and provide important wildlife habitat, consistent with State of 11 Ohio watershed improvement and wildlife conservation policies. 12

Circleville Solar's Sound Level Assessment, discussed further by Witness Callahan, resulted in a finding that construction noise impacts will be intermittent and limited in duration. Consistent with this assessment, any negative impacts from construction noise will be minimized by practices such as limiting hours of work, locating staging away from sensitive receptors, and controlling vehicle movement to prevent backup alarms. Once operational, the Project would be expected to have minimal adverse noise impacts on the adjacent community.

Visual impacts of the Project will be mitigated by the substantial setbacks, flat terrain, low profile of the solar panels, and preservation of existing natural vegetative screening. The setbacks for the vast majority of the Project exceed the current OPSB proposed setbacks in the pending rulemaking (e.g., 300 ft. from panels to residences, 150 ft. from panels to roads). More specifically, the Project's setbacks include:

- The nearest non-participating residence is 600 feet from Project facilities
- Approximately 91% of the Project fence line is sited greater than 1,000 feet from public roads
- Approximately 95% of the Project fence line is sited greater than 500 feet from public roads

1 The Project will also use perimeter fencing that includes agricultural-style, wildlife friendly 2 fencing, rather than chain link fencing. As stated earlier in my testimony, the Glint and 3 Glare analysis shows that there is no predicted glare occurrences for nearby residences or 4 roadways as a result of the proposed single-axis tracking arrays. The results are based on 5 the application of Federal Aviation Administration (FAA) glint and glare standards.

As discussed above, the Staff Report recommended denial of the application, in part, under 6 R.C. 4906.10(A)(3) due to insufficient information supporting the suitability of the 7 geotechnical and subsurface infrastructure. Subsequent to the Staff Report, Circleville 8 Solar provided additional investigative information to the OPSB Staff, followed by the 9 Additional Geotechnical and Subsurface Infrastructure Information filed on October 28, 10 2022. As a result of this additional information, Staff confirmed in written correspondence 11 to Circleville Solar that Staff no longer recommends denial of the application under R.C. 12 4906.10(A)(3). 13

# Q.33 Is the facility consistent with regional plans for expansion of the electric power grid of the electric systems serving this state and interconnected utility systems and that the facility will serve the interests of electric system economy and reliability? [R.C. 4906.10(A)(4)]

18 A.33 Yes. The regional plans for expansion of the electric power grid of the electric systems 19 serving the state are determined by PJM. The Applicant submitted an interconnection request to PJM on January 31, 2017. The Feasibility Study for the Project was received in 20 21 July 2017, and the subsequent System Impact Study Report from PJM was received in June 22 2018. The Facilities Study Report was issued by PJM in October 2022. The 23 Interconnection Service Agreement and Interconnect Construction Service Agreement 24 were executed by Circleville Solar at the end of 2022.

# Q.34 Does the facility comply with the requirements established by the state of Ohio for air pollution control; solid and hazardous waste; water pollution control; permitting for a major increase in withdrawal of waters; and aeronautical requirements? [R.C. 4906.10(A)(5)]

A.34 Yes. The Project will generate no wastewater, no air emissions, and minimal solid waste.
 Air quality permits are not required for construction or operation of the Project. During

construction, Circleville Solar will control fugitive dust by using best management
 practices, consistent with fugitive dust rules.

The Application addresses water and water pollution and demonstrates that the Project has 3 no water pollutants associated with the operations of the Project. The Project does not 4 anticipate any impacts to public or private wells or water supplies during the construction 5 and operation of the Project. Circleville Solar will construct the facility in a manner 6 7 consistent with the Ohio Environmental Protection Agency's Guidance on Post-Construction Storm Water Controls for Solar Panel Arrays. As noted by the Staff Report, 8 9 Circleville Solar will mitigate potential water quality impacts associated with storm water runoff by obtaining NPDES construction storm water general permit (OHC00005, or future 10 versions of this permit) coverage from the Ohio EPA with submittal of a notice of intent 11 for coverage under that permit. The construction storm water general permit also requires 12 development of a Stormwater Pollution Prevention Plan ("SWPPP") to direct the 13 14 implementation of construction related storm water management and BMPs for soil erosion control. 15

Only a minimal amount of solid waste will be produced during regular operations and will 16 be limited to common materials, such as cardboard and plastic packaging. Circleville Solar 17 will recycle as much as possible and will use a local solid waste disposal service to handle 18 19 the waste. Further, Circleville Solar has committed to only use top tier equipment suppliers and the Applicant is only considering panels that have been certified to comply with the 20 US EPA's toxicity characteristics leachate procedure ("TCLP") test and meet U.S. EPA 21 definition of non-hazardous waste. Moreover, Condition No. 36 of the Staff Report requires 22 that retired panels marked for disposal shall be sent to an engineered landfill with barrier 23 and methods designed to prevent leaching of materials into soils and groundwater 24

# Q.35 Does the facility serve the public interest, convenience, and necessity? [R.C. 4906.10(A)(6)]

A.35 Yes. As discussed throughout my testimony and the testimony of other witnesses,
 Circleville Solar has designed the Project to minimize adverse impacts and incorporate
 feedback from the local community. In addition, the Project also actively serves the public
 interest in a variety of ways not addressed in the Staff Report. The public interest is served

by 1) providing local, regional, and statewide economic benefits; 2) the hiring of talented 1 2 local labor to build the project, bringing good construction related jobs to workers in the 3 area, 3) advancing farmland preservation and providing ecological benefits through water quality improvements and additional pollinator habitat; 4) supporting the reliability, 4 affordability, and diversification of Ohio's electrical supply; and 5) directly serving Ohio 5 consumers and communities through an off-take agreement with the state's community 6 aggregation. None of these benefits are referenced in the Staff Report. A number of 7 Circleville Solar's witnesses provide direct testimony on these topics, which will enable 8 the Board to make an evidence-based determination that the Project will serve the public 9 interest, convenience, and necessity. 10

Q.36 Does the Application enable the Board to determine what the facility's impact will be
 on the viability as agricultural land of any land in an existing agricultural district?
 [R.C. 4906.10(A)(7)]

14 A.36 Circleville Solar has taken extra steps to preserve the long-term viability of the property within the Project Area for future agricultural use. These efforts include survey methods to 15 16 identify drain tile and a commitment to repair damaged drain tile, as well as engaging with 17 a local drain tile expert. Circleville has agreed to Staff Report Condition No. 16, which requires that a grading plan is developed and submitted prior to construction. This plan 18 must demonstrate that the Project would not obstruct future agricultural land use or land 19 use otherwise specified by the landowner. Circleville Solar's efforts to minimize grading 20 21 impacts is discussed in more detail by Witness Brooks. The Vegetation Management Plan 22 contained and the conditions set forth in the Staff Report, will ensure that, throughout the life of the Project, a mix of perennial grasses and flowering forbs will increase biodiversity 23 and soil health and has the potential to increase pollinator species presence on adjacent 24 farmed parcels. 25

# Q.37 Does the facility incorporate maximum feasible water conservation practices, considering available technology and the nature and economics of the various alternatives? [R.C. 4906.10(A)(8)]

A.37 Yes. As noted in the Staff Report, the Project will not require the use of significant amounts
 of water. Construction and operations will require a water supply either from existing water

wells, drilling a new well, or having water delivered. Water will be needed for dust control,
 construction trailers, and O&M building use. During operation, natural precipitation is
 expected to be sufficient for cleaning panels.

Q.38 Does the facility comply with the requirements established by the state of Ohio to
prepare and provide a decommissioning plan and cost estimate for the Project?

Yes. Circleville Solar will adhere to the new statutory decommissioning requirements 6 A.38 7 authorized under Ohio Senate Bill 52. Senate Bill 52 requires a decommissioning plan 8 prepared by a registered professional engineer be submitted to the OPSB at least 60 days before construction. The plan must include a list of responsible parties, a schedule for 9 10 decommissioning not to extend beyond 12 months after the utility facility ceases operations, and an estimate of the full costs of decommissioning, without the inclusion of 11 12 salvage value. A performance bond equal to the estimate of decommissioning must be posted and updated every five years. The Application includes a Preliminary 13 Decommissioning Plan (Exhibit K), which will be updated consistent with the statutory 14 requirements and Staff Report Condition No. 35 prior to construction. 15

# Q.39 Do you believe the Project would have a positive impact on the local, regional, and statewide economy?

A.39 Yes. As set forth in the Economic Impact Report (Exhibit H) and in Witness Hollowell's 18 direct testimony, the Project is expected to directly and indirectly benefit the local and 19 statewide economies. As noted in the Economic Impact Report and the OPSB Staff Report, 20 the Project is expected to create 514 construction related jobs for the state of Ohio, as well 21 as six long-term operational jobs for the state of Ohio. The Project is also expected to 22 23 generate between \$37.2 million in local earnings during construction. Construction of the Project is expected to result in over \$63 million in economic output during construction for 24 the state of Ohio, and approximately \$1 million in ongoing annual output during operations. 25 The Project will also create significant revenue to local government and schools. For 26 example, if the Project enters in to a payment in lieu of taxes under R.C 5727.75 with 27 Pickaway County, a \$9,000 per MW PILOT will generate \$630,000 per year for local 28 government entities and schools. Over the life of the Project, PILOT payments would total 29 approximately \$25 million. Annually, with a PILOT, the Westfall School District would 30

1		receive \$258,000 in revenue, Pickaway County would receive \$260,000 in revenue, and
2		Jackson Township would receive \$34,000. Currently, the land underlying the Project area
3		generates approximately \$31,000 annually in local tax revenue in total.
4	Q.40	Please describe Circleville Solar's public information program to provide the local
5		community information about the Project.
6	A.40	In addition to meeting with the surrounding neighbors and the tenant farmers on multiple
7		occasions, the Project team has met with the following local officials and community
8		leaders:
9	Q.41	Did you review the written public comments submitted to the docket in this
10		proceeding?
11	<b>A.4</b> 1	Yes. I have reviewed every comment on the docket as of March 20, 2023.
12	Q.42	Did you review the transcript of the local public hearing held on June 27, 2022?
13	A.42	Yes.
14	Q.43	Please describe, generally, the topics raised by those testifying at the local public
15		hearing and in the written public comments in the docket.
16	A.43	I first note that the overwhelming number of comments to the public docket and testimony
17		in the local public hearing were not specific to the Project. Instead, these comments and
18		testimony expressed concerns or opposition about solar generically, with no reference to
19

community; 3) concerns about panel disposal and toxic chemicals; and 4) safety and
 emergency response.

# 3 Q.44 How does the Project address the concerns raised above?

A.44 Again, the overwhelming number of comments and witness testimony was not directed
toward this Project – indeed, many comments and witness testimony were directed
specifically to *other* solar projects in the area. However, the Project effectively addresses
the general concerns raised:

# 8 Loss of Farmland

9 Many commenters and local hearing witnesses expressed concern about the general loss of 10 farmland as a result of solar development in Pickaway County. The opposition to the Circleville Solar Project by the Pickaway County Board of Commissioners was expressed 11 in terms the loss of farmland in the context of *all* solar development in Pickaway County. 12 In the County resolution opposing the Project, the Commissioners highlighted the 13 14 permitted Atlanta Farms Solar Project (2,276 acres), the Yellowbud Solar Project (2,040 acres) in Ross and Pickaway Counties, and then identified proposed development in the 15 County as "[t]he project areas for the facilities by Scioto Farms Solar Project, LLC, 16 Chipmunk Solar LLC, and Circleville Solar, LLC, would respectively consume 1,070 17 18 acres, 3,680 acres, and 756 acres . . . . "

- The Circleville Solar is by far the smallest of the proposed projects, and as noted earlier in my testimony, the 756 acres reflects an overbuild design and the Project footprint will cover an area less than 756 acres. Although this information was presented to the County Commissioners, their resolution did not reflect this fact.
- Importantly, within this modest Project area, Circleville Solar is committed to developing, 23 constructing, and operating a project that compliments the rural character of the 24 community. When done correctly, solar facilities can be removed so that the underlying 25 land can be returned to farming. Circleville Solar will be constructed and operated in a 26 27 manner to achieve this important objective. As discussed further by Witness Brooks, NEER utilizes a "civil lite" approach to project development. NEER has significant experience in 28 executing these construction methodologies. Moreover, the OPSB Staff Report 29 recommends (Condition No. 16) that the Project develop, for Staff's review, a grading plan 30

"which demonstrates . . . that the project would not obstruct future agricultural land use." 1 2 I note that the previously permitted projects in Pickaway County did not have this 3 condition. Circleville Solar will also ensure that the Project will not create adverse impacts to drainage. In addition to Staff Report recommended Condition No. 25, requiring prompt 4 repair or rerouting damaged field tile systems, Circleville Solar retained a local drain tile 5 expert to support in the identification of these systems. These efforts will help ensure that 6 the Project will not adversely impact the long-term productivity of the land for agricultural 7 8 use.

9 Moreover, the Project provides an opportunity for long-term farmland preservation. As discussed in more detail by Witness Gebhardt and Witness Locker, the Project will provide 10 a period of rest and recovery for the soil. During the life of the Project, the soil will not be 11 exposed to chemicals such as fertilizers and pesticides, and the vegetation within the 12 Project area will help build organic material in the soil. The Project will also provide 13 14 significant pollinator habitat, which benefits other agricultural production in the local area. 15 Fundamentally, I believe that the Project's design approach underscores the deep respect and appreciation that the Project team has for the rural character of the local area. We 16 purposefully designed the Project to have a modest footprint with the largest setbacks of 17 any OPSB-reviewed project in the state (discussed more below). Our objective was not to 18 19 build the biggest project possible but to rather design a project that fit well with the local area while also bringing the myriad of benefits associated with the Project: the opportunity 20 for aggregated Ohio communities to obtain renewable energy benefits from an Ohio-based 21 solar project; economic development and local jobs; and increased revenue for local 22 government and schools. 23

# 24

# Aesthetic Impact to the Community

This Project's setbacks set it apart from all others reviewed by the OPSB. As noted earlier in my testimony, approximately 91% of the Project fence line is sited greater than 1,000 feet from public roads, and 95% of the Project fence is site greater than 500 feet from public roads. The nearest non-participating residences are 600 feet from the Project facilities. For context, the current OPSB rulemaking proposes setbacks of 150 feet from panels to the road and 300 feet from non-participating property owners. Previously permitted projects—

which are all significantly larger in size to Circleville Solar—in Pickaway have setbacks 1 2 well within these thresholds, such as a project setback of only 50 feet from the public roads. In addition to the large setbacks, the Project will maintain existing vegetative screening. 3 The Project will also utilize agricultural style fencing. Finally, the Project will implement 4 5 additional vegetative screening consistent with the Staff Report recommendations.

6

# **Panel Disposal and Toxic Chemicals**

As discussed above, the Project will only utilize panels that have been certified to comply 7 with the US EPA's TCLP test and meet U.S. EPA definition of non-hazardous waste. 8 Condition No. 36 of the Staff Report requires that retired panels marked for disposal shall 9 be sent to an engineered landfill with barrier and methods designed to prevent leaching of 10 materials into soils and groundwater. Witness McConnell's testimony further discusses this 11 subject, included the detailed response and information provided to the EMA Director. 12

13 Safety and Emergency Response

As required by Staff Report Condition No. 39, Circleville Solar will develop and 14 implement an emergency and response plan for its construction and maintenance 15 16 contractors. This plan will be developed in consultation with local emergency response 17 personnel. Moreover, Circleville Solar will provide training for local responders to support 18 a prompt response to emergencies at the solar facility. Moreover, in response to a comment by the EMA Director for Pickaway County, Circleville Solar met with this official to 19 discuss his concerns about solar energy generating facilities and filed a detailed response 20 to his comment, which is discussed in more detail by Witness McConnell. 21

#### Q.45 Q: Did you review the resolutions passed by the Pickaway County Commissioners 22 23 and Jackson Township?

A.45 Yes. The one-page resolution passed by Jackson Township opposes the Project on the basis 24 25 that "a large group of residents" object to it and that the Trustees "believe that the Circleville Solar project is not in the best interest of the residents of the township." The 26 resolution identifies no specific issues about the Project. Indeed, the resolution is identical 27 to another resolution by Jackson Township opposing two different solar projects. No 28 differentiation or comparison is made between any of the other projects and Circleville 29

Solar, despite the fact that one of the other projects is over five times the size of the
 Circleville Solar project.

Similarly, the resolution passed by the Pickaway County Commissioners opposing the Project is identical to other resolutions that the County has passed opposing other solar projects. The County resolution against the Project lists the other potential solar developments in Pickaway County and makes a summary statement that the Project will not "promote the general health, safety, and welfare of the residents of Pickaway County." No specific issues or concerns to the Project are raised.

9 As demonstrated in the Application and direct testimony submitted on behalf of the Project, the Project poses no health risk to the residents of Pickaway County. Circleville Solar has 10 diligently addressed safety concerns and has committed to ensure that local emergency 11 personnel are trained and have the equipment they need. There is no evidence in this 12 docket, or before the Pickaway County Commission demonstrating that the Project poses 13 a safety risk to the residents of Pickaway County. Furthermore, by bringing new tax 14 15 revenue to local government and schools, improving soil and watershed health, bolstering local grid resiliency, and creating local jobs, the Project promotes the general welfare for 16 the residents of Pickaway County. With over 90% of the project more than 1,000 feet from 17 public roads – which is an unprecedented setback compared to other projects approved by 18 19 the Board – and its comparatively small footprint, the Project will truly have minimal impacts to the general public. 20

# Q.46 Please describe Circleville Solar's concerns about the Pickaway County Commissioners' vote to pass a resolution opposing the Project.

23 A.46 Circleville Solar's first concern pertains to the role of Pickaway County's ad hoc member's deciding vote on the resolution in opposition to the Project. The Pickaway County 24 25 Commission has three members. As required by Senate Bill 52, the County Commissioners appointed an ad hoc member to the OPSB for this case on March 29, 2022. The ad hoc 26 27 member appointed for this case is one of the three County Commissioners, Jay Wipple. Following this appointment, he refused to meet with Circleville Solar during the Pickaway 28 County Commission meetings or to engage in any discussion regarding the Project in his 29 capacity as a County Commissioner on the stated basis that he is voting member of the 30 31 OPSB as the ad hoc appointee for this case. Nevertheless, Commissioner Wipple did not

abstain and instead cast the deciding vote to pass the County's resolution in opposition to
the Project. He publicly passed judgment on the Project, notwithstanding his recognition
that he later would be required to hear evidence in this case as *ad hoc* OPSB member.

Circleville Solar is also concerned about the lack of notice and process related to the 4 passage of the County resolution in opposition to the Project. For example, after the 5 Application was deemed complete by the Board (April 4, 2022), Circleville Solar 6 7 scheduled a meeting with the Pickaway County Commissioners for April 19, 2022. The purpose of the meeting was to provide a project update and overview and engage with the 8 9 Commissioners about potential concerns and opportunities to address any such concerns. 10 However, the week before the scheduled meeting took place, the Commissioners passed the resolution opposing the Project on April 12, 2022. See Attachment B. There was no 11 public notice that the resolution would be proposed, considered, or voted on at the April 12 12<sup>th</sup> meeting. As a result, Circleville Solar was unaware of and unable to attend the 13 14 Commissioner's meeting where the vote took place. Then, when the meeting with Circleville Solar occurred on April 19th following the passage of the resolution, 15 Commissioner Henson was absent and Commissioner Whipple refused to participate in the 16 meeting with Circleville Solar on the basis of his status as an *ad hoc* member. See 17 Attachment B. 18

# Q.47 Are you aware that the Pickaway County Commissioners filed a resolution to the Circleville Solar OPSB docket on February 24, 2023 replacing Commissioner Wipple as the *ad hoc* member with a non-Commissioner?

22 A.47 Yes.

# Q.48 Does this address your concerns about Commissioner Wipple's participation as an *ad hoc* member?

A.48 No. At issue is the fact that Commissioner Wipple declined to meet with Circleville Solar
 in open meetings on the basis that he had a conflict of interest because of this service as an
 *ad hoc* member of the Board. However, despite having the same conflict of interest and
 despite having actively refused to be informed about the project, he chose to sit as
 Commissioner and voted against the Project. While replacing him as an *ad hoc* member
 does remove concerns about continuing his participation on the Board later in this

proceeding having already publicly "judged" the Project, it does not change his earlier
 participation as the deciding vote on the resolution opposing the Project.

# 3 Q.49 Does this conclude your testimony?

4 A.49 Yes. However, I reserve the right to update my testimony to respond to any further
5 testimony, reports, and/or evidence submitted in this case.

#### In the Matter of Chipmunk Solar Project:

#### Commissioner Wippel excused himself from the session.

Commissioner Scherer and Commissioner Henson advised the group that Commissioner Wippel recused from the session due to being an Ad Hoc member of the Ohio Power Siting Board for the Scioto Farms Solar Project. Steve Gardner said that it is a very confusing process and asked how the Brown County Solar Tour went? Mr. Gardner described the Yellowbud Project from his view this morning. Mr. Garner explained that the Chipmunk application stated that there was a PILOT payment and the Commissioners advised that they did not enter into a PILOT Program. Mr. Garner asked about abatements and the Commissioner explained that the PILOT is for abatements and stands for Payment in Lieu of Taxes. Chris Weaver discussed an illness that was discovered in another county by their local Health Department. The illness was caused by standing water in the solar fields and it seems to effect individuals under the age of 20 years old. Per Mr. Weaver, there are 450,000 acres in Ohio in brown fields. There are disputes concerning solar with in the county amongst residents. Ohio revised code 303.58 involves the re-submission of an application and Commissioners acting. The timing for the process/ grandfathered in is not when applied to the Ohio Power Siting Board, it is when the application was submitted to the PJM. Mr. Weaver explained that back in 2013-2015 they stored 30-50 million panels in warehouse that are already obsolete. None of the Good Neighbors Contracts have been honored. Licking County Solar is 125 megawatts, and they are building a 50 acre pad to place batteries. The Chipmunk Solar Project is 4 times the size. Mr. Weaver suggested that a Good Neighbor thought would be to build the local fire stations to these solar farms a new station, purchase two fire engines, and hire four full-time firemen to pay for ten years until a levy can be passed.

Mr. Garner has received calls from landowners that solar companies are looking into the St. Rte. 104 and Commercial Point area. It is the Solar Company's goal to have 14 million acres of solar panels. Individuals close to a solar farm have concerns, their cows will not go near it, will not breed and it has affected their internet. Mr. Weaver discussed the concern of the reflection from the sun back into the atmosphere and affecting the weather. Eight of the individuals that have signed their land to lease do not live in Pickaway County. Mr. Weaver is all for a landowner being able to do what they want with their land, except when it affects his land, livelihood, and all that his family has built.

Mr. Williams asked what the Commissioners next step is since they have been discussing with an attorney. Commissioner Scherer and Commissioner Henson explained that they have appointed Commissioner Wippel as an Ad Hoc Member and the time has passed to appoint an intervener for the Scioto Project. Mr. Williams expressed that this is on the Commissioners watch and it will affect the next election.

Mr. Weaver showed a video of the transformers to see how load the transformers are, and they get louder with moisture and rain. These transformers will be across from Mr. Weavers home. Another concern is he was presented with foliage that EDF Renewables was going to put in place across from Mr. Weavers' Home and yet what they will be planning is seedling plants. Mrs. Garner explained that a local homeowner she spoke with stated that they will have to move due to having a special needs child and the sounds will affect the child's daily life. Mr. Weaver asked Commissioner Henson what his main concern is and Commissioner Henson stated that one of his concerns is that is does not have local zoning hoops to go through and he is for landowners rights. Another is the future of farmland and it being used for solar. Commissioner Scherer has the same thoughts. Steve Gardner stated that the landowners are not doing anything illegal, but it is affecting neighbors and the community. Mr. Weaver has concerns of these large companies coming in just to take the money and then they file bankruptcy, and the landowners lose their land. The group thanked the Commissioners for their time.

Commissioner Jay Wippel re-joined the meeting for Palmer Energy Electric Contract session.

In the Matter of Participation Agreement Regarding Electricity Purchase Program of the CCAO Service Corporation Signed:

The commissioners approved a 36-month (June 2022- May 2025) electric supplier agreement with Palmer Energy, which partners with the County Commissioners Association of Ohio Service Corporation (CCAOSC), in providing energy cost savings to CCAO members. As a result, it necessary to enter into a **Participation Agreement Regarding Electricity Purchase Program of the CCAO Service Corporation** in order to create and adopt comprehensive guidelines for the funding, management, and administration of CCAOSC's electricity purchase program.

Upon a brief discussion, Commissioner Gary Scherer offered the motion, seconded by Commissioner Harold Henson, to approve the Electricity Supply Agreement with Freepoint Energy Solution, LLC.

In the Matter of Solar Energy with Swing State Strategies for Scioto Farms Solar Project:

#### \* Commissioner Wippel excused himself from the session.

Mike Hartley, Swing State Strategies, Dylan Borchers and Frank Merrill, Bricker and Eckler, met with the Commissioners to give a general update of Candela Renewables and Scioto Farms Solar Project. They have held a public information meeting with landowners. Mr. Borchers main focus in Energy is solar and wind. The Candela Renewable project is a 110 mw in Scioto Twps. The project has their application pending at the Ohio Power Sitting Board and their project has been deemed as complete and waiting to really get into the project. In early April their schedule should be coming out with findings and specifications. After the staff's report comes out the local community hearing will be held with a court reporter and the community gets to speak. After that, the hearing will be held in August at the Ohio Power Siting Board. There should be a final decision on the project in fall of 2022.

Mr. Hartley explained that the site plan has changed due to concerns from neighbors. The Hillcrest project (Brown Co. 260 megawatt) is one of the first projects approved and had a standard set of regulations. Now there are a set of new regulations for visual. Rural fencing has to be used, vegetation and adjustments to RUMA. If they incorporate a PILOT, it requires that funds be set aside for future road concerns. Commissioner Henson addressed that there were damaged panels laying at the Brown County Solar site and asked what will be done. Mr. Borcher explained that they will have to be disposed of and Commissioner Henson asked when, Mr. Borcher went on to state that he was not sure, the project is not complete and still under construction. Commissioners advised that the panels are generating electricity. Mr. Merrill stated that there can be a stipulation by the Commissioners that damaged panels be removed by a deadline. The Commissioners noticed vacant homes near the site. Commissioner Scherer asked if the Board requires changes does the Board go ahead and approve with requirements and Mr. Borchers explained that it is required that they have to provide that the requirements have been met before construction can be started. Commissioner Henson feels that the disposal process should already be addressed, and a site should be cleaned immediately, not leaving hundreds of broken panels laying on a site. The Power Purchase Agreement states that and once power is running to it, it is considered now commercial operating. Mr. Merrill addressed that the issue is usually financial, due to the construction developer and financing the final project.

December the OPSB provided a listing of developers that were grandfathered in except the Ad Hoc Members. Birch, Kingwood and Cepheus were listed as being recommended by staff for denial and Commissioner Scherer asked about the situation. Mr. Borchers explained that those cases are under litigation and will be up to the Board. There has been suspension in all three cases, and ongoing concerns to address in the community. The project team will be here in April and the technical experts will be able to answer questions. Once Mr. Merrill learned where the Scioto Farm Project was located, he had concerns due to knowing a lot of individuals living in the area. He informed Candela to reach out to the individuals. A lot of these companies coming to the county are asking if there is renewable energy and Mr. Merrill feels that Ryan Scribner will have a hard time not being able to answer that questions for larger companies looking to come to Pickaway County. Mr. Borchers can send a guideline of concerns that the staff member will review before giving their staff report.

#### Commissioner Jay Wippel re-joined the meeting for Auditor's Report

#### In the Matter of Auditors Monthly Update:

Melissa Betz, County Auditor, met with the Commissioners to provide an update for the month of January. The cash balance was at \$10,160,546.64 and started the month at a balance of \$10,726,900.13. The Treasurer had to back out real estate payments to balance and re-input the payment pertaining to TIFF's. The issues were two incentive payments. Rocky Express did not fully pay their real estate's taxes for the first half. It is leaving the Harrison Township Fire \$150,000 short. Mr. Betz is hoping that they will pay it all with the second half. The convenience fees continue to grow and does not seem to be slowing down.

Commissioner Wippel discussed that the Commissioners took a tour of the Brown County Solar Farm and it looked like the project was up and running and over capacity since last June, however, they had not paid any taxes. Commissioner Wippel asked Mrs. Betz if she would have any insight. The project is not certified complete, and they still have road repairs to complete, but has been generating power. Mrs. Betz asked if it more beneficial to not do a PILOT and tax it as a public utility. Commissioner Scherer asked if Mrs. Betz could find out any information of who to contact to find additional information. There was concern that the Brown County Solar Farm did not come out of CAUV, and recoupment paid. Mrs. Betz will see what information she can gather.

Commissioner Scherer asked if there were any blithe properties that Ms. Betz was aware of and she addressed Kingston Mound Apartments and Village of New Holland. Kingston Mound Apartments make a payment in lieu of taxes due to issues with fire and EMS.

**WHEREAS**, the Pickaway County Board of Commissioners (hereinafter referred to as the "Political Subdivision") hereby submits this written agreement to participate in the Ohio Department of Transportation's (ODOT) annual road salt bid in accordance with Ohio Revised Code 5513.01(B) and hereby agrees to all of the following terms and conditions in its participation of the ODOT road salt contract:

- a. The Political Subdivision hereby agrees to be bound by all terms and conditions established by ODOT in the road salt contract and acknowledges that upon of award of the contract by the Director of ODOT it shall be bound by all such terms and conditions included in the contract; and

The Department, upon receipt, will respond that it has received the request and that it has effectively removed the Political Subdivision's participation request. Furthermore, it is the sole responsibility of the Political Subdivision to ensure ODOT has received this participation agreement. #### In the Matter of Auditor's Monthly Update:

Melissa Betz, County Auditor, met with the Commissioners to provide a report of March month end. March ended at \$10,189,658.01 and April started with a cash balance of \$12,150,133.17. Mrs. Betz does not see conveyance fees slowing down anytime soon and there have been a lot of conveyances for Commercial Point. Departments look good since we are only into April. Sales tax was \$90,000 more than this time last year. The dog tag sales are still growing with on-line sales. The Auditor is holding a training for township fiscal officers April 28<sup>th</sup> and Mrs. Betz asked how many solar projects are being considered in Pickaway County. Commissioner Wippel explained Atlanta Solar Project, Yellowbud Solar Project, Scioto Solar Project, Circleville Solar Project, Chipmunk Solar Project and Circleville Transmission Line. The Commissioners have only approved a PILOT for Atlanta Solar Project and denied the Yellowbud Solar Project. The Commissioners are not approving any other PILOTS for projects in the county. Commissioner Scherer asked Mrs. Betz if Bath and Body Works had contacted her, and she explained that they did regarding property taxes. The Commissioners are working with Ryan Scribner, P3, to plan tours of the new warehouses on State Route 104 and Mrs. Betz explained that being apart of the CRAA, visit should be made. The companies have been working well with Mrs. Betz's appraisers.

#### In the Matter of Allocation of January 2022 Sales Tax Collections:

Commissioner Gary Scherer offered the motion, seconded by Commissioner Jay Wippel, to allocate the February 2022 Sales Tax collections in the following manner:

#### In the Matter of Scioto Solar Farm:

Mike Hartley, Swing State Strategies, Mark Carney, Kim Schreckengost and James Cook, Candela Renewables met with the Commissioners to provide an update of the Scioto Solar Farm Project. Mr. Hartley started with the Scioto Farms set of Representative Conditions. There were concerns of the disposal and cleanup. There will be an environmental specialist there on site to make sure that the cleanup is maintained, and reports have to be provided. Commissioner Scherer explained that the Pickaway County EMA Director has prepared documentation that has been filed with the Ohio Power Siting Board regarding site and environmental impact. Mrs. Schreckengost discussed when tax payments will be made. Commissioner Scherer addressed that Brown County is generating power but not paying taxes yet and asked where is that power going if it is not generated for the grid. Mr. Cook explained that the grid operator will monitor and yes, it is generating power. That power could be sold into the PJM market. It would depend on the contract with the power plant. The commercial operation date is when the project is complete, and the grid operator signs off that everything is working correctly, and it is generating power. They could set a plan to layout the process for a start date as commercial operating. Mr. Carney stated that they have started a conversation regarding vegetation and animals on the solar farm. Mrs. Schreckengost has been meeting with Neighbors regarding the Good Neighbors Program. Mr. Cook stated that the idea regarding a PILOT is to guarantee the county has a clear and predictable revenue stream. The flip side is if you're looking at it without a PILOT it is unpredictable and depreciation of equipment. Mr. Hartley will make sure that when the staffs report comes out to come back in to meet with the Commissioners. Commissioner Scherer advised that the County has retained counsel regarding solar.

#### In the Matter of Circleville Solar Project:

Jim Samuel and Ally Sexton, Nextera Energy Resources, LLC, met with the Commissioners regarding the Circleville Solar Project. Ms. Sexton and Dylan Borchers, Bricker and Eckler, discussed the schedule of the project. November 18<sup>th</sup> and March 10<sup>th</sup> will be an open house, June 10<sup>th</sup> OPSB staff issues Staff Report of Investigation, June 27<sup>th</sup> Local Public Hearing, July 22<sup>nd</sup> Deadline for Stipulation and July 26<sup>th</sup> Evidentiary Hearing. Ms. Sexton explained that NextEra maintains the project for the life of it and Commissioner Scherer explained that he did make a trip to the Bowling Green Project in Wood County. The Bowling Green Project is similar to the size of the Circleville Solar Project. The Bowling Green Solar Project (20MW) was under the 50MW therefore, did not require OPSB approval, yet the project voluntary conforms or exceeds most state requirements. The Circleville Solar Project is a 70MW facility equivalent of powering 25,000 homes. The project is 575 acres with 3.6-mile transmission line. The setbacks to minimize potential impacts for Circleville Solar for a residential structure is 600 feet from the nearest structure to equipment.

Circleville Solar "civil-light" approach is constructing solar sites, the project minimizes ground disturbance to the land underneath panels. Any topsoil removed for grading will not be removed from the site. Low growing vegetation will be planted throughout the facility. After decommissioning, the field will be returned to agriculture. Commissioner Scherer asked how far the pole will be placed in the ground, and it was explained that the post will be placed 10'-12' into the ground. Commissioner Scherer also asked how they will know if tile had been hit or damaged while placing the poles and Ms. Sexton explained that they will not know immediately, but Mark Ruff has placed most of the tile in these fields and they will be working with Mr. Ruff during the entire project. Mr. Borchers discussed that they have not had a lot of concerns from the community, other than two families. The PILOT has requirements that may not be there if there is no PILOT. One being workforce requirements and apprenticeship requirements. Mr. Samuel. Not having a PILOT could require upfront cost that are higher, and he knows that legislation just passed that does not give the schools the ability to negotiate property values. Commissioner Scherer addressed the safety and environmental impact of the materials in the panels and that the Pickaway County EMA Director submitted a memo of the Environmental Impact to the OPSB.

#### Commissioner Jay Wippel returned to meeting

#### In the Matter of County Fiber Expansion Discussion with Horizon:

Tom Wetmore and JP West, Horizon, met with the Commissioners to discuss fiber expansion in Pickaway County. Mr. West has been working with broadband for 3.5 years before COVID and has many townships that are wanting to have the broadband in their areas. Horizon has been in business for 125 years. Horizon can offer a robust Hosted Voice, Internet and Ethernet services up to 100 Gbps, dark fiber and wavelength services. State of the art network and reputation for quality and customer experience with first bill review making certain there is a full understanding of services, 60 second Fiber-alert notice/ 30 minute e-mail notifications until resolution and average mean time to repair is within four hours, compared to 6 to 8 hours industry average. Local presence 24/7/365 NOC, project managers and executive team located in Columbus with no 3<sup>rd</sup> party billing (all done in-house) and support calls ne go west coast or overseas. Major focus on network growth and acquisition with capital and financial backing. Industry leading 99.5% retention rate, a genuine partnership approach while instituting a proactive relationship with customers, vendors and community.

Horizon partners NOVACAP and GCM Grosvenor are at their side providing significant advantages to continue on the path of growth and transformation. This allows for Horizon to enhance services for existing customers, acquiring new clients and partners, while pursuing new markets in the years ahead. Horizon deploys dedicated fiber network, not a passive optical network (PON) network. Dedicated glass fiber strands go to each customer rather than through a splitter in a PON network. This allows for more bandwidth now and into the future, as well as positioning Horizon for advanced technologies years out without reconstructing the network. Horizon FTTP internet is designed to be a "2 Hop" network; meaning that they have a very efficient means of routing traffic to the internet in only two "hops". This is due to less equipment for the internet traffic to flow through and provides for lower latency and overall better experience to the customer. Two "hops" means literally that they want the customer internet traffic to only touch two pieced of Horizon equipment before it is into the internet. For example, most residential internet networks are between 8-12 "hops" today.

Mr. West explained why households need FTT fiber optic. Households are growing by the number of smart devices and the need for the devices. Households need for work, school, social media, gaming, streaming and has grown to need for Tele Medicine, virtual doctor appointments and shopping. In addition to households, small business need for credit cards transactions, televisions, customer Wi-Fi, phone service and cloud and cyber security. Horizon will be able to over better, faster service for a lower cost to household s and business with great customer support in the United States. Mr. West and Mr. Wetmore offered an invitation for the Commissioners to visit their facility in Columbus to see what Horizon has to offer Pickaway County.
