**{¶ 1}** Commission Staff served a notice of preliminary determination upon Debra A. Booth (Respondent) in accordance with Ohio Adm.Code 4901:2-7-12, alleging a violation of the Commission's transportation regulations.

**{¶ 2}** On May 17, 2022, Respondent filed a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.

**{¶ 3}** As set forth in Ohio Adm.Code 4901:2-7-16(B), unless otherwise ordered by the Commission or agreed by the parties, a prehearing conference in a civil forfeiture case shall be scheduled upon the filing of a request for administrative hearing.

**{¶ 4}** A prehearing conference was held between Respondent and Staff on July 21, 2022; however, the parties were unable to reach a settlement during the prehearing conference.

**{¶ 5}** By Entry issued December 14, 2022, the attorney examiner scheduled this matter for hearing on March 23, 2023, at the offices of the Commission.

**{**¶ **6}** On March 20, 2023, the parties filed a settlement agreement in which Respondent and Staff state that they have reached an agreement to resolve all issues in the above-captioned case.

**{**¶ 7**}** Based upon the filing of the settlement agreement between the parties, the attorney examiner finds that the hearing scheduled for March 23, 2023, should be canceled. Consideration of the settlement agreement will occur in a subsequent Commission entry.

**{¶ 8}** It is, therefore,

**{¶ 9}** ORDERED, That the hearing scheduled for March 23, 2023, be canceled, in accordance with Paragraph 6. It is, further,
