# AT&T OHIO'S APPLICATION FOR AN EXEMPTION FROM THE REQUIREMENTS OF SECTION 4927.12 OF THE REVISED CODE THROUGHOUT ITS SERVICE TERRITORY

#### Introduction

AT&T Ohio ("AT&T" or "the Company"), by its attorney, and pursuant to R. C. § 4927.123 and O. A. C. § 4901:1-6-14, hereby applies for an exemption from the requirements of R. C. § 4927.12 throughout its service territory. In support of its application, the Company makes the following showings herein:

AT&T Ohio is an incumbent local exchange carrier ("ILEC") that provides basic local exchange service (sometimes referred to as "BLES" here) in 192 exchanges throughout the State of Ohio. Today, the pricing of that service is subject to the restrictions of R. C. § 4927.12.

This application is being filed no earlier than four years after the effective date of R. C. § 4927.123, as provided therein. That section took effect on March 20, 2019. See Attachment 1 (an authenticated copy of R. C. § 4927.123 with the effective date, March 20, 2019, noted).

#### The Application Meets The Statutory Requirements

The Company demonstrates that it has experienced at least fifty per cent line loss in each of its exchange areas since January 1, 2002. "Line loss" is defined in the statute as follows:

"Line loss" refers to the number of access lines, whether residential or commercial, for which a customer of an incumbent local exchange carrier has terminated local exchange service.

R. C. § 4927.123(A). Attachment 2 details the line loss experienced in each of the Company's 192 exchanges since January 1, 2002. That attachment includes data updated as of the end of the month of January 2023, as noted.

The Company also demonstrates that one (or more) of the following criteria applies in each of its exchange areas:

- (a) The Company increased its rates for basic local exchange service for the exchange area within the twelve months prior to September 13, 2010;
- (b) The Commission made a determination that the exchange area qualified for alternative regulation of basic local exchange service under Chapter 4901:1-4 of the Ohio Administrative Code as that chapter existed on September 13, 2010; or
- (c) The Company filed an application for the exchange area that was approved or deemed approved under division (B)(3)(b) of section 4927.12 of the Revised Code.

Attachment 3 details the criteria met, by exchange, for each of the Company's 192 exchanges. The criteria are designated (a), (b), and (c) in the statute and on Attachment 3. The criteria are designated (i), (ii), and (iii) in the Commission rule, O.A.C. § 4901:1-6-14(F)(1)(a).

As to criterion (a), the Company increased the rates for primary small business BLES lines in its Access Areas B and C effective January 4, 2010 (a date that is within the twelve months prior to September 13, 2010).

As to criterion (b), 176 of the Company's 192 exchanges were determined by the Commission to qualify for alternative regulation of basic local exchange service under Chapter 4901:1-4 of the Ohio Administrative Code as that chapter existed on September 13, 2010.

Attachment 4 lists the cases in which those determinations were made and the number of exchanges to which the determinations applied in each case.

As to criterion (c), the Company's application for its 16 remaining exchanges was deemed approved under division (B)(3)(b) of section 4927.12 of the Revised Code. Attachment 4 also includes the details on that case in its last entry.

#### Conclusion

Having met all the requirements of the applicable statute and rule, the Company's application should be approved or allowed to be "deemed approved" pursuant to the applicable statutory provisions.

#### Ohio Revised Code

Section 4927.123 Exemption for incumbent local exchange carriers.

Effective: March 20, 2019


Legislation: House Bill 402 - 132nd General Assembly

(A) As used in this section:

"Exchange area" has the same meaning as in section 4927.12 of the Revised Code.

"Line loss" refers to the number of access lines, whether residential or commercial, for which a customer of an incumbent local exchange carrier has terminated local exchange service.

- (B) Not earlier than the date that is exactly four years after the effective date of this section, an incumbent local exchange carrier may apply to the public utilities commission for an exemption from the requirements of section 4927.12 of the Revised Code for an exchange area, subject to division (E) of this section.
- (C) The commission shall approve an application under division (B) of this section if the carrier demonstrates that both of the following apply:
- (1) The carrier has experienced at least fifty per cent line loss in the exchange area since January 1, 2002.
- (2) One of the following applies:
- (a) The carrier increased the carrier's rates for basic local exchange service for the exchange area within the twelve months prior to September 13, 2010.
- (b) The commission made a determination that the exchange area qualified for alternative regulation of basic local exchange service under Chapter 4901:1-4 of the Ohio Administrative Code as that chapter existed on September 13, 2010.
- (c) The carrier filed an application for the exchange area that was approved or deemed approved



under division (B)(3)(b) of section 4927.12 of the Revised Code.

- (D) On the thirty-first day after the filing of an application under division (B) of this section, the commission shall be deemed to have found that the application meets the requirements of division(C) of this section unless the commission, within thirty days after the filing of the application, issues an order finding that the requirements have not been met.
- (E) If an application for an exchange area is approved or deemed approved under this section, the incumbent local exchange carrier that filed the application shall be exempt from the requirements of section 4927.12 of the Revised Code for the exchange area to which the application applies, except that the carrier may not alter the carrier's rates for basic local exchange service below the carrier's incremental cost. "Incremental cost" has the same meaning as in section 4927.12 of the Revised Code.
- (F) Nothing in this section shall be construed to impair the rights of any person to file a complaint with the commission under section 4927.21 of the Revised Code, or the rights of the commission to initiate such a complaint, against an incumbent local exchange carrier who has been granted an exemption under this section.
