UNOPPOSED MOTION OF DUKE ENERGY OHIO, INC., TO MODIFY THE PROCEDURAL SCHEDULE AND REOUEST FOR EXPEDITED RULING

Now comes Duke Energy Ohio, Inc. (Duke Energy Ohio or Company), by and through counsel, and hereby moves the Public Utilities Commission of Ohio (Commission), in accordance with Rule 4901-1-12(C), Ohio Administrative Code (O.A.C.), for an extension of the deadline to file testimony in the underlying matter. As the current procedural schedule dictates, supplemental testimony by Duke Energy Ohio and direct testimony by intervenors is due by April 11, 2023. For the reasons outlined below, the Company requests, and the intervening parties and Staff do not oppose, an extension for the filing of testimony supporting objections, until April 21, 2023. It

should be noted that the parties to the underlying matter seek to maintain the May 23, 2023 hearing date for this case.

Rule 4901-1-12(C).

MEMORANDUM IN SUPPORT

The procedural schedule in this proceeding is currently set to require the filing of supplemental testimony by Duke Energy Ohio and direct testimony by intervenors by April 11, 2023. The Company proposes that this date for the filing of testimony be extended until April 21, 2023, an extension of approximately ten days. The Company has reached out to all intervening parties and Staff regarding this change, and none of the parties oppose this Motion. Moreover, the parties do not seek to extend or change the currently set hearing date of May 23, 2023.

O.A.C. 4901-1-12(A) permits the extension of deadlines for good cause shown. Duke Energy Ohio seeks an extension of the current procedural schedule for one primary reason: to allow the continuation of meaningful settlement discussions prior to the Parties locking in their respective litigation positions via testimony. The intervening parties and the Company have met many times in previous weeks and months, and additional time in which to attempt to reach concurrence among the parties would be beneficial to the status of the underlying case.

As indicated above, a brief extension to the procedural schedule for submittal of testimony supporting objections to the Staff Report will allow parties to conduct remaining settlement conferences and hopefully reach a deal in principle between some or all parties. More specifically, if a stipulation and recommendation is reached, parties will instead file testimony in support of the stipulation, and, if necessary, testimony opposing the stipulation prior to the May 23, 2023 hearing date. Duke Energy Ohio notes that the Commission has previously granted similar motions to provide time to engage in settlement discussions in other rate case proceedings.²

As stated above, Duke Energy Ohio requests an extension of the due date for the filing of all testimony that is currently required to be filed on April 11, 2023, such that the referenced testimony would be due instead on April 21, 2023. Likewise, the parties endeavor, with only a ten day extension, to maintain the currently set May 23, 2023 hearing date in this case. Counsel has been contacted for all parties to this proceeding, and the parties do not oppose this request for an extension. For the reasons set forth above, Duke Energy Ohio respectfully requests that the Commission expeditiously grant this motion.
