{¶ 1} Pursuant to R.C. 4905.10, by Entry issued January 26, 2022, the Commission directed all regulated entities to file a 2021 annual report for fiscal assessment through the PUCO Community, the Commission's web-based filing system, by April 29, 2022. The Commission uses the annual report information to generate invoices that are then sent to the annual report filers on or before the first day of October consistent with R.C. 4905.10(B) to fund the operations of the Commission.

{¶ 2} On April 13, 2023, Cleveland-Cliffs Steel LLC (Cleveland-Cliffs) filed a motion for leave to late file its competitive retail electric services annual report for calendar year 2021 pursuant to Certificate No. 11-364E. Cleveland-Cliffs states that it recently discovered inadvertent errors in its reported 2021 volume and gross revenue figures. Upon approval of this motion and the unlocking of the 2021 annual report in the PUCO Community, Cleveland-Cliffs commits to correcting the volume and gross revenue information and re-submit its 2021 annual report. Cleveland-Cliffs notes that with the correction, the Commission's fiscal department will be able to adjust the amount of Cleveland-Cliffs' annual assessments for 2021.

{¶ 3} The attorney examiner determines that Cleveland-Cliffs' motion for leave to file an amended annual report for calendar year 2021 should be granted. Cleveland-Cliffs is directed to contact the Commission's Fiscal Division to make arrangements to submit its corrected 2021 annual report for fiscal assessment.

{¶ 4} It is, therefore,

{¶ 5} ORDERED, That the motion filed by Cleveland-Cliffs be granted in accordance with Paragraph 3. It is, further,

{¶ 6} ORDERED, That a copy of this Entry be served upon Cleveland-Cliffs.
