- {¶ 1} R.C. 4511.63 provides that, except where the Commission has granted an exemption, any bus, school vehicle, or vehicle transporting a material that is required to be placarded pursuant to 49 C.F.R. Parts 100-185 must stop before crossing at grade any railroad track. This section also provides that any local authority may file an application with the Commission requesting approval of an exempt crossing.
- {¶ 2} On February 27, 2023, Randy Smith, the Trumbull County Engineer, filed a letter requesting an exemption for school buses and motor vehicles carrying certain hazardous materials from stopping at the grade crossing DOT No. 262-604C located immediately south of the intersection of South Leavitt Road and West Market Street in Leavittsburg, Warren Township, Trumbull County.
- {¶ 3} Accordingly, the attorney examiner finds that Staff should file a report of investigation regarding the request by June 2, 2023.
- {¶ 4} Further, the attorney examiner finds that, in order for the public to have an opportunity to comment on the exemption request, a local hearing should be scheduled. Accordingly, a public hearing on this matter should be held on May 22, 2023, at 2:00 p.m., at the Trumbull County Law Library, 120 High St. NW, Warren, OH 44481.
- $\{\P 5\}$ The Secretary of the Commission should cause publication of the following legal notice in a newspaper of general circulation in Trumbull County, Ohio, one time, not less than seven days prior to the scheduled hearing:
