Specifically, costs will be captured through FERC formula rates for the ATSI Transmission Zone, Attachment H-21 in the PJM OATT.

#### PROPOSED CONDITION FOR STAFF REPORT OF INVESTIGATION:

Staff has recommended certain recurring certificate conditions for prior segments of the Knox-Nottingham Transmission Line Rebuild Project. Without either waiving any objection to or admitting the lawfulness of such condition(s), ATSI proposes language for Staff's consideration in lieu of restating the second condition that was included in Staff Reports of Investigation relating to prior segments of the Knox-Nottingham Transmission Line Rebuild Project:

• Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations that do not conflict with or otherwise inhibit the certificate authority granted in this case, the Applicant shall obtain and comply with such permits or authorizations.
