On January 20, 2023, the Ohio Power Siting Board, through its administrative law judge (“ALJ”), issued an Entry that ordered the parties to file their lists of issues for cross-examination by April 27, 2023. In the January 20, 2023 Entry, the ALJ instructed the parties to file a “list of issues citing specific concerns about which they may be interested in pursuing cross-examination of witnesses at the evidentiary hearing”<sup>1</sup> Ohio Partners for Affordable Energy (“OPAE”) hereby submits its cross-examination issues list, noting it reserves the right to supplement this list upon the filing of additional testimony as well as forgo to pursue cross-examination if it chooses despite an issues inclusion on this list:

1. OPAE may pursue cross-examination of any person(s) called as a witness in this proceeding; and

OPAE reserves the right to amend or supplement this list of issues based upon direct testimony of other intervenors and issues raised during cross-examination by other intervenors. Further, the lack of inclusion of any issue in this list does not constitute a waiver of OPAE's right to cross-examine any witness regarding that issue.
