4 ATTORNEY EXAMINER HICKS: The
5 Public Utilities Commission of Ohio has called
6 for hearing at this and place Case No.
7 21-882-TR-CVF which is captioned In The Matter
8 of DOXA, LLC.

9 My name is David Hicks, and I am
10 the Attorney Examiner assigned by the Commission
11 to hear this case. We are going to go ahead and
12 begin things by taking appearances from counsel,
13 being with Staff.

14 MS. WNEK: Ashley Wnek representing
15 the Ohio Attorney General's office and
16 the Public Utilities Commission.

17 ATTORNEY EXAMINER HICKS: Thank you.
18 And on behalf of Respondent.

19 MR. MAHER: Thank you, your Honor.
20 Colin Maher, 00844567 on behalf of DOXA, LLC.

21 ATTORNEY EXAMINER HICKS: Thank you.
22 Prior to us starting the hearing it is the
23 Bench's understanding that the parties have had
24 some discussions. I am just going to open it up
25 to either counsel to outline what may have been

1 decided and how they would like to proceed at
2 this point.

3 MS. WNEK: Thank you, your Honor.
4 This stems from a violation that occurred on
5 June 10th, 2021. We have had some preliminary
6 discussions regarding this violation that was
7 Code Section 177.834 A. It was a hazmat.

8 After some preliminary discussions
9 we have come to an agreement with the Respondent
10 that the \$440 would be paid by Respondent at the
11 discounted rate of 20 percent. So 20 percent
12 will be taken off of \$440. And it's our
13 understanding that that will be paid by the
14 Respondent.

15 MR. MAHER: And that's correct, your
16 Honor.

17 ATTORNEY EXAMINER HICKS: Okay. I
18 presume a settlement agreement will be drafted
19 at some point by the parties.

20 MS. WNEK: Yes, your Honor. A
21 settlement agreement will be drafted and
22 provided to the Respondent for signature.

23 ATTORNEY EXAMINER HICKS: Okay.
24 Based on that then I don't think we need to
25 proceed with a more formal structure of a

1 hearing today. The Court will wait to see
2 the settlement agreement that is presented and
3 filed. Should anything happen that that does
4 not come to fruition certainly file something in
5 the docket and we can restart things. But
6 hopefully that is a non-issue.

7 Outside of that do either of you
8 have anything further?

9 MR. MAHER: That's all we need for
10 today.

11 MS. WNEK: Nothing further, your
12 Honor.

13 ATTORNEY EXAMINER HICKS: All
14 right. Thank you. We are adjourned.
