Good afternoon Nathan,

Please find attached the in-stream work restriction waiver request for the Duke Gas on the V000B Pipeline Replacement Project in Cincinnati, Ohio (ODNR 22-0424). The project includes installing new pipeline segments in three locations and abandoning the existing pipeline in place. One of the three locations crosses Duck Creek and required a Section 404 Nationwide Permit 12 approval along with a Section 408 clearance for impacting the levee adjacent to Duck Creek. The project also requires a Ohio Siting Board Construction Notice, and we are currently working through that process with the OPSB.

Please note that Duck Creek at this location is more like a concrete stormwater conveyance and not likely to provide suitable habitat for aquatic species. I've included a screenshot below of a photo from our wetland delineation report of Duck Creek for reference (labeled as Stream S-1 in the report). Given the space and topographic constraints in this area and at the request of USACE, Duke Gas will be open cutting through the concrete channel of Duck Creek and installing the pipeline.

The project is scheduled to start construction in early May. Therefore, we are requesting a 72-hour in water work waiver to accommodate the extra time needed for concrete work in Duck Creek.
