**NOTICE OF CANCELLATION AND POSTPONEMENT
FOR AMERICAN TRANSMISSION SYSTEMS, INCORPORATED'S
PUBLIC INFORMATIONAL MEETING**

American Transmission Systems, Incorporated ("ATSI") hereby gives notice to the Ohio Power Siting Board that the public informational meeting ("PIM") scheduled pursuant to Ohio Administrative Code ("OAC") Rule 4906-3-03(B) for Tuesday, March 16, from 6:00-8:00 p.m. at the Tyler Mahoning Valley History Center located at 325 W. Federal Street, Youngstown, Ohio 44502, has been cancelled and will instead be held on a later date. ATSI is postponing the PIM in order to further evaluate newly-identified supply chain constraints that may impact design aspects and responses to recent public comments. After the conclusion of this analysis, which ATSI estimates will take up to 6 weeks, ATSI will reschedule the PIM and issue new notices pursuant to OAC Rule 4906-3-03(B)(1)-(2).

Letters to property owners and affected tenants, an exemplar of which is attached as Exhibit 1, were sent by U.S. Postal Service First-Class Mail on May 8, 2023. ATSI will also cause notices to be posted at the Tyler Mahoning Valley History Center on May 16, 2023, starting at 5:30 p.m., until the PIM was set to be concluded (at 8:00 p.m.).
