#### MEMORANDUM IN SUPPORT OF THE MOTION TO SUSPEND PROCEDURAL SCHEDULE

On January 5, 2022, Sportsman's Market, Inc. ("Sporty's") and Brian Jobe (collectively, "Respondents") submitted a request for an administrative hearing with the Public Utilities Commission of Ohio ("Commission") in this proceeding. A hearing is currently scheduled for May 26, 2023. Sporty's plans on calling its Chairman and CEO, Mr. Michael Wolf, as a witness during the hearing.
