The Applicant, **Continental Telephone Company**, hereby modifies its intrastate switched access tariff to reduce intrastate Toll-Free Switched End Office rates to bill-and-keep (\$0.00) and Query Charges to a transitional rate of no more than \$0.0002. These changes are in response to the Federal Communications Commission's Report and Order and Further Notice of Proposed rulemaking, WC Docket No. 18-156, FCC 20-143, § 51.909 (o) (Released October 9, 2020). This order requires Rate of Return Carrier's to effectuate the preceding revisions, effective July 1, 2023. These rates will mirror the Company's interstate rates.

The Company views these tariff changes as administrative because they are consistent with the FCC's rules.
