On December 15, 2022, the Ohio Power Siting Board (OPSB) issued a Certificate to Grover Hill Wind, LLC (Grover Hill Wind) for the construction, operation and maintenance of a wind-powered electric generation facility of up to 150 megawatts in Paulding County, Ohio, in OPSB Case No. 20-417-EL-BGN (Facility).
