COMMENTS OF DUKE ENERGY OHIO, INC.

Comes now Duke Energy Ohio, Inc., (Duke Energy Ohio or the Company) and respectfully submits its comments regarding administrative rules in O.A.C. Chapter 4901:1-22 (Chapter 22), addressing interconnection standards. The Public Utilities Commission of Ohio (Commission) issued an entry on May 17, 2023, proposing substantive changes to reduce the total number of regulatory restrictions present as well as non-substantive changes to provide clarity and correct typographical errors. Pursuant to the Commission entry, initial comments were to be filed no later than June 2, 2023.²

I. COMMENTS

The Company comments only to identify what it believes to be two minor errors, one clerical and one grammatical.

First, the current version of O.A.C. 4901:1-22-01(A)(3) refers to "a distributed energy resource as defined in paragraph (K) of this rule." The Company believes that this should be

corrected to refer to "paragraph (L)," which contains the definition of a distributed energy resource.

Paragraph (K) defines "cost recovery."

Second, the definition of "minor modification" in O.A.C. 4901:1-22-01(U) appears to be missing words or to contain incorrect words in the underlined portion below:

"Minor modification" to an interconnection application means changes to the EDU's electric system, or adversely impact earlier queued interconnection requests, and that would otherwise not be done but for the applicant's interconnection request.⁴

The Company understands that the purpose of this proceeding is primarily to reduce the total number of regulatory restrictions and not to conduct a comprehensive substantive review of the rules. The Company reserves all its rights to make substantive suggestions for rule revisions in the appropriate future proceeding.

II. CONCLUSION

The Company appreciates the opportunity to submit comments in this proceeding.
