Property Value Concerns...

My home and a rental property that I own sit on approximately 20 acres and has an appraised value of approximately one million dollars, and with today's selling real estate prices could very well be more. The impact this project will have on my property value will be devastating. The negative effects of this type of industry lowering everyone's property values in the area are a fact. Who would want to live next to this project? Would any of you? The presence of a project of this nature is a sore sight for eyes. There seems to be a variety of short-term and long-term risks associated with this type of project within agricultural and residential areas, and a decrease in value and condition of these family properties during the project's lifetime and after the abandonment.

Environmental Concerns

What will this project due to the soil? The air? What kind of devastation will be done to this farmland. How much of its topsoil will be removed. Will it be farmable when this project commences and it returns back to farmland. Who restores this land Can it even return back to farmland. And if not, then what?
