## FINDING AND ORDER

Entered in the Journal on June 28, 2023

### I. SUMMARY

{¶ 1} The Commission directs all regulated entities and service providers who have failed to file a 2022 annual report for fiscal assessment and/or a 2022 Telecommunications Relay Service form to do so by July 21, 2023; and, pursuant to R.C. 4905.54 and 4905.84, assesses a civil forfeiture of \$1,000 against every company listed in the attachments to this Finding and Order that fails to comply with this Finding and Order.

### II. DISCUSSION

{¶ 2} Pursuant to R.C. 4905.10, by Entry issued January 26, 2023, in Case No. 23-01-AU-RPT, the Commission directed all regulated entities to file a 2022 annual report for fiscal assessment through PUCO Community, the Commission's web-based filing system, by April 28, 2023.

{¶ 3} Similarly, pursuant to R.C. 4905.84, by Entry issued January 26, 2023, in Case No. 23-03-TP-RPT, the Commission directed all service providers required under federal law to provide customers with access to telecommunications relay service (TRS) to complete and submit, through PUCO Community, a response to the Telecommunications Relay Service Reporting Form (TRS form) by April 28, 2023.

{¶ 4} During April 2023, the Commission was made aware that the State of Ohio's online system upgrades caused technical challenges for entities to file their 2022 annual reports. In light of the perceived mass online system errors, on May 17, 2023, the Commission extended the date whereby all regulated entities were required to file a 2022 annual report for fiscal assessment to June 2, 2023.

{¶ 5} Each regulated entity was instructed to file a separate 2022 annual report for each certificate held. Companies with two or more certificates should submit an annual report for each certificate or authority held during 2022, even if the company did not have intrastate gross earnings during the 2022 calendar year. No annual report is required for certificates issued in 2023. A list of all regulated entities who were instructed to file a 2022 annual report was docketed with the Entry in Case No. 23-01-AU-RPT on January 26, 2023.<sup>1</sup> Moreover, a list of all service providers instructed to file the TRS form for 2022 was attached to the January 26, 2023 Entry in Case No. 23-03-TP-RPT.<sup>2</sup>

{¶ 6} All regulated entities were put on notice that the Commission expected timely compliance regarding the filing of the 2022 annual report. All regulated entities were advised that a civil forfeiture of up to \$10,000, may be assessed, pursuant to R.C. 4905.54, against any company that fails to comply by the June 2, 2023 annual report filing deadline, absent good cause shown. Such forfeiture would be in addition to any amounts owed to the Commission.

{¶ 7} Furthermore, all TRS providers were put on notice that the Commission expected timely compliance regarding the submission of the 2022 TRS form by the April 28, 2023 deadline. All TRS providers were put on notice that a civil forfeiture of up to \$1,000 per day, may be assessed, pursuant to R.C. 4905.84(E), against any company that failed to comply by the April 28, 2023 deadline, absent good cause shown. Such forfeiture would be in addition to any amounts owed to the Commission.

{¶ 8} A review of the Commission's records reveals that the regulated entities and service providers listed in the attachments to this Finding and Order have failed to file an annual report and/or TRS form by the April 28, 2023, or June 2, 2023 deadlines, as applicable. As each of the companies listed in the attachments to this Finding and Order have failed to submit a 2022 annual report and/or a 2022 TRS form by the April 28, 2023 or June 2, 2023 deadlines, as applicable, the Commission directs Staff to assess a civil forfeiture of \$1,000 on these companies pursuant to R.C. 4905.54 for the failure to file a 2022 annual report or pursuant to R.C. 4905.84 for the failure to file a 2022 TRS form.

{¶ 9} Furthermore, each listed company must file its 2022 annual report and/or its 2022 TRS form by July 21, 2023, through the Commission's web-based filing system known as the PUCO Community. In order to file by the July 21, 2023 deadline, each listed company should request leave to file by sending an electronic mail message to [pucofiscalsupport@puco.ohio.gov](mailto:pucofiscalsupport@puco.ohio.gov). Those entities that do not file by the July 21, 2023 deadline will be in noncompliance of a Commission directive and could be assessed an additional forfeiture pursuant to R.C. 4905.54 and 4905.84. Failure to file could also result in the Commission rescinding the entities' certificate and order them to cease providing regulated service in the state of Ohio under the listed certificate.

{¶ 10} The effective date of the forfeitures assessed through this Finding and Order should be delayed 30 days to afford the companies listed in the attachments an opportunity to file an application for rehearing pursuant to R.C. 4903.10.

### III. ORDER

{¶ 11} It is, therefore,

{¶ 12} ORDERED, That Staff assess a \$1,000 civil forfeiture against each entity listed in the attachments to this Finding and Order. It is, further,

{¶ 13} ORDERED, That each entity listed in the attachments to this Finding and Order file its 2022 annual report and/or 2022 TRS form by July 21, 2023, through the Commission's web-based filing system known as the PUCO Community. It is, further,

{¶ 14} ORDERED, That the effective date of the forfeitures assessed through this Finding and Order be delayed 30 days in accordance with Paragraph 10. It is, further,

{¶ 15} ORDERED, That notice of this Entry be served via the Electric-Energy, Gas-Pipeline, Railroad, Telephone, and Water industry service lists; upon all telephone companies and commercial mobile radio service providers under the Commission's jurisdiction through the Ohio Telecom Association; upon those entities who filed the TRS form under the previous remittance period through the TRS industry service list; directly upon each company contact which was filed on the docket of the above-caption cases; and upon all other interested persons of record.
