Dear Attorney Examiner Schabo:

I am writing to inform you that The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO or the Company), Interstate Gas Supply, LLC (IGS); Direct Energy Business LLC, Direct Energy Services LLC, Direct Energy Business Marketing LLC, Energy Plus Natural Gas LLC, Reliant Energy Northeast LLC, Stream Ohio Gas & Electric, LLC, and XOOM Energy Ohio, LLC (the NRG Retail Companies); the Retail Energy Supply Association (RESA); and the Office of the Ohio Consumers' Counsel (OCC) have agreed to waive cross-examination of the testifying witnesses in this proceeding and have further agreed that the following exhibits may be admitted into the hearing record:

- Joint Exhibit 1.0, Stipulation and Recommendation (filed March 28, 2003)
- Joint Exhibit 2.0, Bill Format Changes (filed March 28, 2003)

Given this agreement, the parties believe that the hearings scheduled for July 12 and
