For the reasons discussed in the Memorandum in Support, DISH requests a four-month extension from today to November 8, 2023, as indicated in DISH's accompanying memorandum.

## MEMORANDUM OF DISH WIRELESS L.L.C. IN SUPPORT OF ITS AMENDED MOTION FOR AN EXTENSION OF THE DEADLINE FOR PLACING NEW NUMBERS INTO SERVICE

DISH Wireless L.L.C. ("DISH") qualified to receive numbering resources in the following Rate Centers (Central Office Codes): ASHTABULA (440-825-8); MARYSVILLE (937-819-5); MIDDLEFIELD (440-705-9); MILLERSPORT (220-500-4); OSTRANDER (740-766-8); SEDALIA (740-874-0); SIDNEY (326-206-1); SMITHVILLE (234-477-0); and URBANIA (937-772-0). The North American Number Plan Administrator ("NANPA) granted to DISH blocks of numbers in the above-listed rate centers. DISH's due dates for submitting its NANPA part 4 form are outlined below:<sup>2</sup>

This is DISH's first extension request for the following rate centers: Millersport, Ostrander, Sedalia, Sidney, Smithville, and Urbania. The Chesterville and Richfield blocks have been activated and assignment of numbers has commenced and DISH is no longer requesting a third extension for Chesterville and Richfield, as it is moot.

Onboarding of DISH customers is taking longer than expected, but new customers are being added daily. These rates centers are in DISH's Cleveland market, which just launched on January 24, 2023, and DISH's Columbus market, which just launched on March 29, 2023, under the Boost Infinite product; DISH could acquire a customer in these rate centers at any time. Since DISH's last motion for an extension of time in April, DISH fulfilled one of its enforceable commitments to the Federal Communications Commission ("FCC") by completing construction of a greenfield telecommunications infrastructure that provides 5G wireless coverage to 70% of the U.S. population. Although there were some unanticipated delays in achieving this monumental task—which prevented DISH from obtaining subscribers—DISH achieved this milestone on June 14, 2023. It also recently onboarded a third-party corporate vendor, Peerless Network<sup>3</sup>, who requires use of the blocks of numbers outlined above.

To provide DISH's corporate vendor sufficient time to utilize the blocks of numbers and for DISH to activate service, DISH respectfully requests a four-month extension of the part 4 submission date to November 8, 2023, as indicated above. Additionally, the identified rate centers now have coverage, and requiring DISH to return these number blocks would preclude DISH from providing telephone numbers to customers for at least 33 days during the re-ordering interval. This would not only prejudice DISH, but also impact its customers.
