MOTION OF THE JOINT APPLICANTS FOR A PROCEDURAL SCHEDULE

Joint Applicants the University of Dayton, Tallgrass Dayton Community Power, LLC

("Tallgrass"), and The Dayton Power and Light Company d/b/a AES Ohio ("AES Ohio") seek

approval of a reasonable arrangement, and hereby move to establish a procedural schedule for

the Commission's consideration and approval of the Joint Application.

The proposed reasonable arrangement will enable the University of Dayton to utilize

clean renewable energy for its facilities sourced from a waste heat recovery system owned and

operated by Tallgrass using heat from an existing natural gas compression site in AES Ohio's

service territory, with no cost allocated to any other AES Ohio customer.

Given the nature of this proposed reasonable arrangement, the Joint Applicants propose a

schedule that does not contemplate or require a formal hearing. Accordingly, under Ohio Adm.

Code 4901-1-12(A), Joint Applicants move for the Commission to adopt the procedural schedule

now required for this case. Joint Applicants' proposed procedural schedule is:

## MEMORANDUM IN SUPPORT OF MOTION OF THE JOINT APPLICANTS FOR A PROCEDURAL SCHEDULE

The Commission possesses broad discretion to manage its dockets and set appropriate procedural schedules. *Duff v. Pub. Util. Comm.*, 56 Ohio St. 2d 357, 379, 384 N.E.2d 264 (1978); *Toledo Coalition for Safe Energy v. Pub Util. Comm.*, 69 Ohio St. 2d 559, 560, 433 N.E.2d 212 (1982). The Joint Applicants ask the Commission to enter the proposed procedural schedule in this matter so that the Joint Applicants may commence work on this project, which would allow the University of Dayton to source its generation service directly from a local and clean renewable energy resource.

As noted in the Joint Application, this long-term sustainable power project is a key component of the University of Dayton's ongoing efforts towards sustainability. The waste-to-heat technology to be deployed by Tallgrass will create additional, local renewable energy that is clean and carbon free, and will be distributed by AES Ohio to the University of Dayton with no cost to any other AES Ohio customer.

For the reasons identified above, the Joint Applicants request the proposed procedural schedule set forth in the Motion.
