Dear Director:

You are receiving this letter because we wanted to let you know about a proposed transmission line project in your area.

AEP Ohio representatives plan to replace a single steel pole along the Beatty-Canal 138-kilovolt transmission Line outside of the White Road Station off White Road in Jackson Township, Franklin County. The company needs to replace the steel pole to reconfigure current equipment and add additional equipment at the station.

We filed a Construction Notification for this project with the Ohio Power Siting Board (OPSB) as the Beatty-Canal 138 kV Transmission Line Re-Termination (White Road) Project, Case No. 23-0011-EL-BNR.

If approved, construction on AEP property begins this summer and concludes by next spring.
