Requests Dated August 10, 2023:

 Staff notes that 42 of the 108 structures for the transmission line have a note indicating "Do Not Construct" on this set of engineering drawings. Explain when the set of engineering drawings for those 42 structures will be provided to staff; also indicate when construction is anticipated to begin on those segments of the electric transmission line.

<u>RESPONSE</u>: Structures indicated on the engineering drawings as "Do Not Construct" will be subject to a forthcoming Application For Amendment to the Certificate of Environmental Compatibility and Public Need that was issued to ATSI in this case. Once the Amendment Application is approved by the Board, ATSI will commission engineering drawings without the "Do Not Construct" indication and provide those to Staff, along with the anticipated construction schedule for the portions of the Project subject to the Amended Certificate.

2) (<u>Stipulation Condition #16</u>) Provide any updated FAA determination of no hazard letters. These may be applicable for those nearest Brim Substation.

<u>RESPONSE</u>: At this time, ATSI is awaiting FAA determinations for structures 3 and 4 nearest Brim Substation. ATSI filed for these structures and for the cranes needed to set them in place on August 2, 20223, but has not received determinations yet. The ASN's are:

2023-AGL-15176-OE 2023-AGL-15177-OE 2023-AGL-15178-OE 2023-AGL-15179-OE

Please note that structures 3 and 4 will be within the scope of the aforementioned Amendment Application, so installation will not occur until an Amended Certificate is issued.

3) (<u>Stipulation Condition #18</u>) Is ATSI planning to use cranes to construct the transmission line? If so, provide the anticipated Start date and End date when the crane would be used.

<u>RESPONSE</u>: Yes, ATSI is planning to use cranes to construct the transmission line. Cranes are anticipated to be used from approximately September 1, 2023 to December 31, 2023.
