- {¶ 1} On August 1, 2023, Fidelis United Energy Solutions, LLC (Fidelis) filed a renewal application for certification as a competitive retail electric service (CRES) provider in Case No. 19-1299-EL-AGG.
- {¶ 2} On the same day, Fidelis filed a renewal application for certification as a competitive retail natural gas service (CRNGS) broker in Case No. 19-1300-GA-AGG.
- $\{\P\ 3\}$ Fidelis filed additional information regarding both of its applications on August 8, 2023.
- {¶ 4} Pursuant to R.C. 4928.08 and Ohio Adm.Code 4901:1-24-10, Fidelis's CRES application is subject to a 30-day automatic approval process. Similarly, pursuant to R.C. 4929.20 and Ohio Adm.Code 4901:1-27-10, Fidelis's CRNGS application is also subject to a 30-day automatic approval process. Both Ohio Adm.Code 4901:1-24-10 and Ohio Adm.Code 4901:1-27-10 further provide that, upon good cause shown, the Commission or an attorney examiner may suspend consideration of a CRES or CRNGS application, respectively. *See also* R.C. 4928.08 and R.C. 4929.20.
