You are receiving this letter because we wanted to update you about a component of a proposed electric transmission project in your area.

AEP Ohio representatives plan to replace approximately 7 miles of steel lattice towers with steel poles in Perry, Morgan and Muskingum counties. The 138-kilovolt (kV) line begins at Ceramic Road in Harrison Township and travels northeast 7 miles to connect to an existing transmission line at the intersection of Center Road and Johnson Hill Road in Brush Creek. Company representatives also plan to replace two wooden poles with steel poles on the separate power line at the intersection of Center Road and Wilson Road in Brush Creek Township, Muskingum County. Company representatives expect construction to begin next February and conclude fall 2023.

AEP Ohio officials filed the following projects with the Ohio Power Siting Board (OPSB):

- **Letter of Notification for the Crooksville-Philo South 138 KV Transmission Line Rebuild Project (Crooksville-Cannelville), Case No. 21-1112-EL-BLN.** This project involves rebuilding 7 miles of transmission line in Perry, Morgan and Muskingum counties.
- **Construction Notice for the Cannelville-Guernsey-Muskingum Co-Op 138 KV Transmission Line Rebuild Project, Case No. 21-1113-EL-BNR.** This project involves replacing two wooden poles with steel poles in Brush Creek Township, Muskingum County.

The nearly 100-year-old transmission lines have shown significant deterioration and have exceeded their lifespan. Replacing deteriorating towers and wooden poles with modern steel poles improves reliability and resiliency of the local electric system.

Please see the attached Letter of Notification and Construction Notice, which we must submit to the OPSB when we make certain changes to our transmission facilities. The submission complies with Rule 4906-6-01, et. seq., of the Ohio Administrative Code.

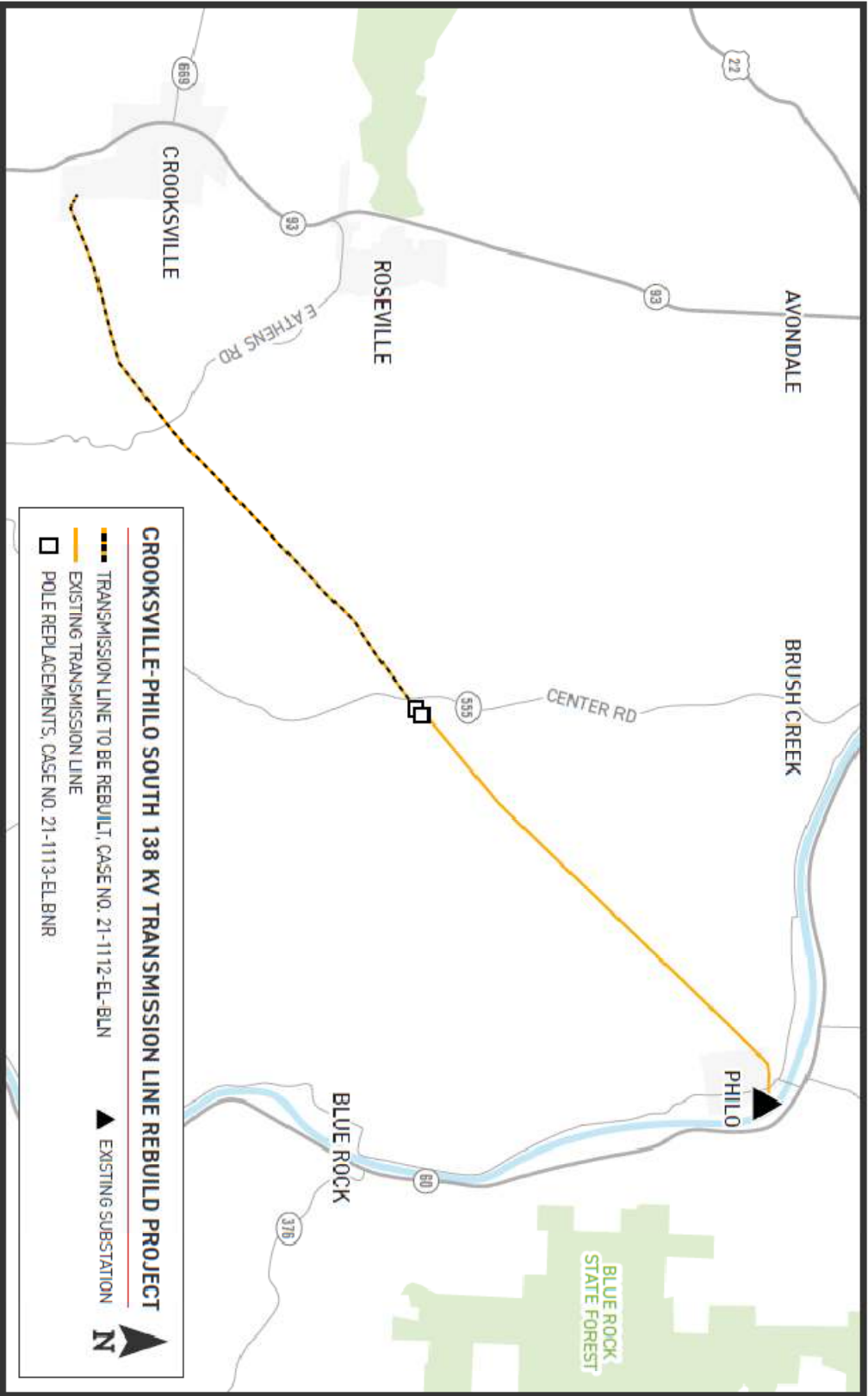
