On August 25, 2023, the OPSB filed a letter in the docket finding that the Application is in compliance Ohio Administrative Code (“O.A.C.”) Chapters 4906-01, et seq.

In accordance with O.A.C. Rule 4906-3-07(A)(4), the undersigned certifies that on September 21, 2023 a copy of the accepted, complete application was served in compliance with O.A.C. Rules 4906-3-07(A)(1) and (2).

Pursuant to O.A.C. Rule 4906-3-07(A)(1), the Applicant served the chief executive officer of each municipal corporation, county, township, and the head of each public agency charged with the duty of protecting the environment or of planning land use in the area where the Project is located with a letter that provided electronic access to the Application. Further, in accordance with the OPSB’s August 25, 2023 letter, these individuals were informed that, if they wish to intervene in the proceeding, they must file a notice of intervention with the Board within 30 days of being served a copy of the letter.
