**FOUNTAIN POINT SOLAR ENERGY LLC'S
RESPONSE TO THE ELEVENTH DATA REQUEST
FROM THE STAFF OF THE OHIO POWER SITING BOARD**

On April 11, 2022, as supplemented on May 16 and August 23, 2022, Fountain Point Solar Energy LLC (“Applicant”), filed an application (“Application”) with the Ohio Power Siting Board (“OPSB”) proposing to construct a solar-powered electric generation facility in Logan County, Ohio (“Project” or “Facility”).

On September 8, 2023, the Staff of the OPSB (“OPSB Staff”) provided the Applicant with OPSB Staff’s Eleventh Data Request. Now comes the Applicant providing the following response to the Eleventh Data Request from the OPSB Staff.

- 1. Please provide an updated map for the facility area as referred to by Applicant Witness Vertucci in his testimony at the evidentiary hearing on August 15, 2023, Tr. at 24.**

Response: The Applicant commits that it will not construct or operate any Project facilities, including the fence, within Rushcreek Township. See the attached maps that reflect this commitment. The Applicant notes the attached maps show the blue line that represents the Project Area boundary in Rushcreek Township, as the Applicant has committed to continue to coordinate with Rushcreek Township and to train and equipment local first responders in the area. Further, the blue line properly reflects the study area for the Project. However, the Applicant emphasizes that no Project facilities, including the fence, will be constructed,

operated, or maintained in Rushcreek Township and respectfully requests that the Board include this commitment in the certificate.
