Dear PUCO,

My comment is for PUCO Case 23-301-EL-SSO, the current FE ESP CASE V.

From what I can discern from journalist coverage, it appears that First Energy and its supporting companies and executives have paid some \$ 50 million dollars in bribes to Ohio legislators. This must have an effect upon raising our electric rates.

The PUCO should order FE and its supporting companies to recover this \$ 50 million dollars of what is really our customer money. This money should be used to help low-income family customers. I also understand that the

Customer Advisory Programs (even at their relatively low funding burden on FE) may be cut entirely.

Until this \$ 50 million is recovered, no rate increases should be allowed to First Energy and its subordinate companies, and the Customer Advisory Programs should continue.

Reject and dismiss this FE filing for ESP Case V.
