CONSTELLATION ENERGY GENERATION LLC AND CONSTELLATION NEWENERGY INC.'S MEMORANDUM CONTRA INTERSTATE GAS SUPPLY, LLC'S MOTION TO STRIKE DIRECT TESTIMONY

Interstate Gas Supply LLC ("IGS") filed a motion on October 2, 2023, seeking to strike "the direct testimony of all intervenors" that was filed prior to the Stipulation and Recommendation ("Stipulation"). Like Northeast Ohio Public Energy Council ("NOPEC"), Constellation Energy Generation LLC and Constellation NewEnergy Inc. (collectively, "Constellation") believe that IGS' motion should be denied. To the extent IGS is seeking to strike such testimony from the docket card, IGS' motion should be denied. IGS has not presented any grounds for such a drastic and sweeping action. To the extent that IGS is seeking to strike pre-Stipulation and pre-filed testimony that a party may seek to admit into the hearing's evidentiary record, IGS' blanket motion is premature. Any motion to strike should only be heard if and when a witness appears and presents testimony for submission into the evidentiary record. Regardless, Constellation does not intend to

submit the pre-filed testimony filed on behalf of Constellation on June 9, 2023. IGS' blanket motion to strike the pre-Stipulation, pre-filed direct testimony should be denied.
