JOINT APPLICATION TO TRANSFER CERTIFICATE FOR INTERCONNECTING SWITCHYARD

Madison Fields Solar Project, LLC ("Madison Fields"), a wholly-owned subsidiary of Savion, LLC, is certified to construct a 180-megawatt solar-powered electric generation facility in Madison County, Ohio ("Project"). The Ohio Power Siting Board ("Board") issued an Opinion, Order, and Certificate ("Order") in Case No. 19-1881-EL-BGN on January 21, 2021, as amended by Order on Certificate issued by the Board in Case No. 21-508-EL-BGA, on October 21, 2021 ("Certificate"), authorizing Madison Fields to construct the solar facility that includes photovoltaic solar modules, access roads, meteorological stations, collection lines, inverters, transformers, a gen-tie line, an operations and maintenance building, a project substation, an interconnecting switchyard, and other associated facilities.

At this time, pursuant to Ohio Revised Code ("R.C.") 4906.04, Madison Fields and American Transmission Systems, Incorporated ("ATSI"), (collectively "Joint Applicants")

seek approval to transfer the portion of the Certificate, that relates only to the interconnecting switchyard that was approved in the above-captioned cases, from Madison Fields to ATSI. The Joint Applicants request that this Joint Application be heard at the next available Board meeting.

As approved by the Board, the interconnecting switchyard is located in the ATSI zone of the PJM Interconnection, LLC control area, and interconnects the Project to the local and regional transmission grid via the East Springfield-Tangy 138 kilovolt transmission line (Order at 21 ¶ 58). The interconnecting switchyard is located in Pike Township, Madison County. Construction of the switchyard commenced in April 2023 and was completed in September 2023. The Joint Applicants are now proposing to transfer the Certificate, only to the extent it relates to the interconnecting switchyard, from Madison Fields to ATSI.

The Joint Applicants acknowledge that the interconnecting switchyard will be subject to the jurisdiction of the Board and remain subject to all the terms and conditions in the Certificate, as it may be amended from time to time. Furthermore, as required pursuant to R.C. 4906.04 and attested to by ATSI in Attachment A to this Joint Application, ATSI agrees to abide by any and all terms, conditions, and modifications of the Certificate.

In addition, Madison Fields has also sent a letter to all public officials explaining the nature of the transfer. An example of the notice and a list of those entities that received the letter are contained in Attachments B and C, respectively, to this Joint Application.

WHEREFORE, the Joint Applicants respectfully request that, pursuant to R.C. 4906.04, the Board approve the transfer of the Certificate issued in this case, to the extent it relates to the interconnecting switchyard, from Madison Fields to ATSI.
