In accordance with R.C. 4929.07(A)(1) and Ohio Adm.Code Rule 4901:1-19-08(A)(1), The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) hereby files this notice of intention to implement the alternative rate plan for its demand-side-management/energy efficiency (DSM/EE) programs, as modified by the Commission in its October 4, 2023 Opinion and Order in this proceeding (21-1109 Order).

The 21-1109 Order denies cost recovery of DEO's proposal to expand its non-low-income DSM/EE programs and orders DEO to wind-down its existing non-low-income DSM/EE program, Home Performance with ENERGY STAR Program. Although DEO believes that Ohio law, Commission precedent and the record in this proceeding support DEO's application, DEO will not be seeking rehearing of the 21-1109 Order. In implementing the modified alternative rate plan, DEO reserves all rights to file for approval of non-low-income DSM/EE programs with the Commission at any time in the future. In addition, DEO reserves the right to revoke or modify this notice of intent or its implementation thereof in the event the 21-1109 Order is later modified, including on rehearing or appeal.

The 21-1109 Order further directs DEO to continue to annually file an application to adjust its DSM Rider. DEO's next such DSM Rider application is due by no later than December 1, 2023. In that filing, DEO intends to address the impact of alternative rate plan as modified by the Commission on DEO's DSM/EE programs and DEO's proposed updated DSM Rider rate. Accordingly, DEO has not included any revised rate schedules with this notice and has not yet filed any revised rate schedules with the Commission.
