You are receiving this letter because you own property in Shelby County, Ohio, near where the Dayton Power and Light Company d/b/a AES Ohio will be constructing upgrades to the local power grid. We are writing to inform you that the construction of the Sidney Substation Expansion Project near your property will be starting soon. This project located within the AES Ohio Sidney Service Center at 2385 Campbell Road, in the City of Sidney and Shelby County. This project is part of wider area improvements that will provide operational flexibility and capacity in this portion of our service territory, which has been prone to multiple and extended outage scenarios during winter ice storms. All construction will take place on AES Ohio property, but because the existing Sidney Substation is near your property, you are being notified about this project.

The Ohio Power Siting Board ("OPSB") approved AES Ohio's Letter of Notification regarding this Project on February 7, 2023. Construction is scheduled to begin on November 1, 2023 and the Project is expected to be in-service by September 16, 2024. AES Ohio does not anticipate that work on this Project will cause service interruptions. As with any construction activities, however, this Project might present temporary inconveniences. We ask for your patience as AES Ohio works to strengthen our infrastructure to provide safe and reliable electric service.

Please note, AES Ohio employees always carry company identification. Contracted personnel also carry company identification along with documentation that they are working for AES Ohio.
