U.K. conservatives promote tax cuts ahead of elections

Minimum wage, pensions also boosted

LONDON - Britain's Conservative government sought to regain the political initiative Wednesday with a series of tax cuts for businesses and individuals that it hopes will bolster its chances in a national election next year that opinion polls suggest it will lose.

Treasury chief Jeremy Hunt said the British economy "had turned a corner," with inflation and government borrowing down, allowing him to offer what he termed the biggest set of tax cuts since the 1980s.

"After a global pandemic and energy crisis, we have taken difficult decisions to put our economy back on track,' he said.

Prime Minister Rishi Sunak and Mr. Hunt are searching for economic news to boost Conservative election fortunes.

Opinion polls for months have put the governing Conservative Party, which has been in power since 2010, well behind the main opposition Labor Party.

The most high-profile measure in Mr. Hunt's autumn budget statement was a biggerthan-expected cut to national insurance - a tax that employees pay - by 2 percentage points to 10 percent, which 27 million individuals are expected to receive in their wages as soon as January.

"If we want people to get up early in the morning, if we want people to work nights, if we want an economy where people go the extra mile and work hard, then we need to recognize that their hard work benefits all of us," he said.

Other potential sweeteners for voters were hefty increases in the minimum wage, pensions, and benefits.

Though Britain avoided the recession that many had anticipated this year, expectations for economic growth have been downgraded by the Office for Budget Responsibility.

N. Korea fired missile toward sea but launch likely failed, Seoul says

SEOUL - South Korea said North Korea fired a ballistic missile toward the sea but the launch likely failed Wednesday night, hours after Seoul said it would resume front-line aerial surveillance in response to the North's spy satellite launch.

South Korea's Joint Chiefs of Staff said Thursday it detected the missile launch from the North's capital region.

It said the missile was fired toward the North's eastern waters but that the launch was believed to have ended in failure. It gave no further details such as what type of missile was fired and what happened to it.

Tĥe launch was North Korea's first known weapons firing in more than two months. Earlier Wednesday, South Korea announced it decided to partially suspend an agreement and restart front-line aerial surveillance of North Korea in reaction to the North's satellite launch the previous night.

South Korea, the United States, and Japan have condemned the North's satellite launch because they believe it was meant to improve the country's missile technology as well as establish a spacebased surveillance system.

U.N. Security Council resolutions prohibit any satellite lift-offs by North Korea, viewing them as covers for testing its missile technology.

U.S., Philippines navies conduct joint patrols in disputed waters

MANILA — The United States and the Philippines are conducting joint air and maritime patrols in the South trying to confirm whether its satellite launch was successful and whether the satellite can perform reconnaissance functions.

North Korea's space agency said its Malligyong-1 satellite was placed in orbit on Tuesday night, about 12 minutes after lift-off.

Leader Kim Jong Un watched the satellite launch on site. He later visited the Pyongyang control center of the North's space agency, where he was briefed that the satellite would officially begin its reconnaissance mission from Dec. 1, following a period of fine-tuning,

The North's official Korean Central News Agency reported that Kim was presented with satellite photos of Anderson Air Force Base, Apra Harbor, and other U.S. military facilities in the U.S. Pacific territory of Guam, which it said were taken Wednesday morning.

It didn't publicize the photos, and many experts remain skeptical about whether the North Korean satellite is advanced enough to conduct meaningful military reconnaissance.

NEW DELHI — India restored electronic visa services for Canadian nationals, an Indian foreign ministry official said Wednesday, two months after Canada alleged the South Asian nation was involved in the assassination of a Sikh sep

aratist in Canada. The move could ease tensions after they swapped accusations and expelled each other's diplomats, with India introducing a visa ban on Canadian nationals.

Anti-Islam populist wins Dutch election

THE HAGUE, Netherlands Far-right, anti-Islam populist Geert Wilders was headed for a landslide victory Wednes day in the Dutch election, according to an exit poll, in a result that is bound to send shockwaves through Europe.

The result puts him in line to lead talks to form a new ruling coalition and possibly become the country's prime minister.

The exit poll published by the national broadcaster NOS said Mr. Wilders' Party for Freedom won 35 seats in the 150-seat lower house of parlia ment, more than double the 17 he won in the last election.

The next closest party was an alliance of the center-left Labor Party and Green Left, which was forecast to win 26 seats

BRUSSELS — European Union lawmakers on Wednesday rejected a plan to reduce the use of chemical pesticides by 50 percent by 2030 and to ban all pesticide use in areas such public parks, playgrounds, and schools.


After a series of amendments watered down the proposal of the E.U. executive commission, the bill was rejected, 299-207 with 121 abstentions.

It buried the bill for good and any new proposal would need to start from scratch after June elections for members of the European Parliament.



A hummus makeover

It's time to dress up for the holidays. While this certainly applies to our wardrobes, here we are talking about hummus. Hummus is a party favorite, easy to make in advance and unfailingly popular. It's also Lynda very beige in color. This Balslev recipe gives the dependable Levantine chickpea-and-tahini dip a hol-

iday makeover, infusing it with a jolt of color and a sprinkle of bling to usher in the festive season.


